NARRATIVE

ON TUESDAY, MARCH 12TH, 2024, AT APPROXIMATELY 0044 HOURS, OFFICERS RESPONDED TO A SHOTS FIRED CALL FOR SERVICE AT THE LISTED ADDRESS. WHILE CONDUCTING A PRELIMINARY INVESTIGATION, OFFICERS WERE NOTIFIED OF A SHOOTING VICTIM AT BAPTIST HOSPITAL. OFFICERS RESPONDED AND LOCATED JAYSHAWN HAMMOCK (B/M; 12/24/2003) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEDICAL PERSONNEL ATTEMPTED LIFE-SAVING MEASURES, HOWEVER, MR. HAMMOCK WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE FOOTAGE. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO BAPTIST HOSPITAL AND TOOK POSSESSION OF MR. HAMMOCK FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
