NARRATIVE

ON SATURDAY, MARCH 23RD, 2024, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED ANDRE ALLEN (B/M; 10/16/1990) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED AND ATTEMPTED LIFE-SAVING MEASURES, HOWEVER, MR. ALLEN WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE. DURING THE COURSE OF THE INVESTIGATION, JUSTIN CROSS (B/M; 11/21/1990) WAS IDENTIFIED AS A SUSPECT IN THIS INCIDENT. MR. CROSS WAS TRANSPORTED TO MAJOR CRIMES FOR FURTHER INVESTIGATION. AFTER A PRELIMINARY INVESTIGATION, MR. CROSS WAS RELEASED WITHOUT CHARGES PENDING A FILE REVIEW. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO THE INCIDENT LOCATION AND TOOK POSSESSION OF MR. ALLEN FOR AN AUTOPSY. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
