## **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A SHOT SPOTTER ACTIVATION. UPON ARRIVAL OFFICERS LOCATED VICTIM-1 AND MS. ALLMON SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS AND LRFD RESCUE WERE NOTIFIED AND RESPONDED TO THE SCENE TO RENDER LIFE SAVING MEASURES, HOWEVER VICTIM-1 AND MS. ALLMON SUCCUMBED TO THEIR INJURIES AND WERE PRONOUNCED DECEASED A SHORT TIME LATER. OFFICERS SECURED THE AREA AND NOTIFIED HOMICIDE DETECTIVES AND CSSU, WHO RESPONDED TO THE SCENE AND BEGAN THEIR INVESTIGATION. THE PULASKI COUNTY CORONER WAS NOTIFIED AND RESPONDED TO THE SCENE TO TAKE CUSTODY OF VICTIM-1 AND MS. ALLMON, TO TRANSPORT THEM TO THE ARKANSAS STATE CRIME LAB FOR AUTOPSY, AND FOR POSITIVE ID OF VICTIM-1. MS. ALLMON'S NEXT OF KIN WAS NOTIFIED. THIS INVESTIGATION IS ONGOING.
