NARRATIVE

OFFICERS WERE DISPATCHED TO UAMS DUE TO A POSSIBLE SHOOTING VICTIM ARRIVING AT THIS LOCATION. OFFICERS ARRIVED AND MADE CONTACT WITH THE VICTIM (MILLER) WHO WAS RESPONSIVE IN TRAUMA ROOM 2. MILLER ADVISED HE WAS WALKING FROM A FRIENDS HOUSE IN THE AREA OF 17TH AND S. PARK STREET WHEN HE OBSERVED TWO UNKNOWN GREY AND WHITE VEHICLES EXCHANGING GUNFIRE. MILLER STATED HE FLED TO A NEARBY RESIDENCE AFTER HE WAS STRUCK IN THE LEFT FOREARM BY A STRAY BULLET. MILLER STATED IT SOUNDED LIKE ATLEAST 20 ROUNDS WERE FIRED BETWEEN THE TWO LISTED VEHICLES. MILLER STATED HE THEN RECEIVED A RIDE TO UAMS FROM AN ACQUIANTENCE KNOWN BY THE NAME "BLOCK". MILLERS INJURY WAS NON LIFE THREATENING AND HE APPEARED TO BE GRAZED ON HIS LEFT FOREARM. OFFICERS RESPONDED TO THE LISTED CRIME SCENE AREA IN ATTEMPT TO LOCATE SHELL CASINGS INVOLVED IN THE SHOOTING WITH NEGATIVE RESULTS. OFFICERS COULD NOT LOCATE A CRIME SCENE IN THE AREA OF 17TH AND S. PARK. SGT. HEALY WAS NOTIFIED OF THIS INCIDENT. MILLER WAS PROVIDED AN INCIDENT NUMBER AND ADVISED DETECTIVES WOULD BE IN CONTACT IF FURTHER QUESTIONING IS NEEDED.
