KING SHOWED UP AT UAMS WITH A NON-LIFE-THREATENING GUNSHOT WOUND.

MAJOR CRIMES DETECTIVES AND CSSU RESPONDED TO THE SCENE. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND VIDEO SURVEILLANCE. DETECTIVES CONTACTED THE NEXT OF KIN FOR MS. MARTIN AT UAMS. THE PULASKI COUNTY CORONER RESPONDED AND TOOK CUSTODY OF MS. MARTIN. THE INVESTIGATION IS ONGOING.
