NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR AN AGGRAVATED ROBBERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH FERNANDO AGUILERA, WHO ADVISED HE WAS OUTSIDE OF HIS RESIDENCE AND 3 BLACK MALES ROBBED HIM AT GUNPOINT. FERNANDO ADVISED THEY WERE ALL YOUNGER, POSSIBLY IN THEIR EARLY 20'S. ONE WAS WEARING A WHITE JACKET AND BLUE JEANS, ONE WAS WEARING A BLUE HOODIE WITH DREADS, AND THE LAST ONE WAS WEARING A HAT. FERNANDO ADVISED AFTER THEY TOOK HIS CASH HE CHASED THEM IN THE DIRECTION OF THE ENTRANCE TO THE COMPLEX. FERNANDO ADVISED THE SUSPECT WITH THE GUN DROPPED THE GUN AND ANOTHER SUSPECT PICKED IT UP AND THEY CONTINUED RUNNING. FERNANDO DID NOT SEE THE SUSPECTS EVER GET INTO A VEHICLE AND DID NOT KNOW A DIRECTION OF TRAVEL ONCE THEY REACHED SHACKLEFORD RD. OFFICERS CIRCULATED THE AREA AND NEARBY BUSINESSES AND APARTMENT COMPLEXES FOR ANYONE MATCHING THE SUSPECTS DESCRIPTION WITH NEGATIVE RESULTS. OFFICERS PROVIDED FERNANDO WITH AN INCIDENT NUMBER AND ADVISED A DETECTIVE WOULD BE IN CONTACT.

NARRATIVE

OFFICERS RECEIVED A CALL TO THE LISTED ADDRESS FOR A ROBBERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. BOB HOPE. MR. HOPE STATED HE WAS ROBBED OF HIS VEHICLE AND MONEY. MR. HOPE ADVISED HE PICKED UP A FEMALE, MS. STEPHANEY FOREMAN, IN ORDER TO EXCHANGE MONEY FOR SEXUAL FAVORS. MR. HOPE ADVISED HE DROVE MS. FOREMAN TO A FRIEND'S HOUSE AT 16 HATFIELD DR. SO THEY COULD ENGAGE IN SEXUAL INTERCOURSE. MR. HOPE ADVISED MS. FOREMAN THEN CALLED MR. SAMUEL BRADY AND MR. DEARIUS SHELTON OVER TO ROB HIM. MR. HOPE ADVISED HE WAS ROBBED AT GUNPOINT OF \$60 TO \$100. HIS PERSONAL BELONGINGS, CELLPHONE, AND HIS CAR. A SHORT TIME LATER, OFFICERS LOCATED VEHICLE 1 PARKED IN THE DRIVEWAY OF THE RESIDENCE AT 10509 DAVID O'DODD ROAD. OFFICERS APPROACHED THE VEHICLE AND OBSERVED A BLACK MALE LATER IDENTIFIED AS MR. CHRISTOPHER SIMPSON SITTING IN A SILVER NISSAN CUBE, WHICH WAS PARKED IN FRONT OF VEHICLE 1. OFFICERS DETAINED MR. SIMPSON FOR FURTHER INVESTIGATION.
