NARRATIVE

ON SATURDAY, AUGUST 24TH, 2024 AT APPROXIMATELY 2126 HOURS, OFFICERS RESPONDED TO AN ASSIST MEDICAL CALL FOR SERVICE AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED LASHABRA PLUNKETT (B/F; 10/30/1995) SUFFERING FROM AN APPARENT LACERATION. MEMS AND RESCUE RESPONDED AND TRANSPORTED MS. PLUNKETT TO A LOCAL HOSPITAL WHERE SHE WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE FOOTAGE. DURING THE COURSE OF THE INVESTIGATION, KEITH MOORE (B/M; 09/05/1987) WAS DEVELOPED AS A SUSPECT. MR. MOORE WAS SUBSEQUENTLY TAKEN INTO CUSTODY. AFTER A PRELIMINARY INVESTIGATION, MR. MOORE WAS SUBSEQUENTLY CHARGED WITH MURDER IN THE FIRST DEGREE. MR. MOORE WAS TRANSPORTED TO PCRJ WITHOUT INCIDENT. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MS. PLUNKETT FOR AN AUTOPSY. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
