NARRATIVE

OFFICERS RESPONDED TO A SHOOTING AT THE LISTED LOCATION. UPON ARRIVAL, OFFICERS OBSERVED V1 (MAYES) LAYING ON THE GROUND WITH A GUN SHOT WOUND TO THE LEFT SIDE OF HIS NECK. MEMS ARRIVED ON SCENE AND HE WAS TRANSPORTED TO BAPTIST HOSPITAL. OFFICERS THEN MADE CONTACT WITH V2 (PRICE). PRICE STATED HER EX-BOYFRIEND, S1 (JOHNSON) WAS AT HER RESIDENCE. JOHNSON STATED HER CURRENT BOYFRIEND, MAYES BECAME UPSET AND WOULD NOT STOP CALLING HER. PRICE STATED JOHNSON THEN STARTED ACTING STRANGE DUE TO THIS AND DISPLAYED A HANDGUN WHILE POINTING IT DIRECTLY AT HER. PRICE STATED JOHNSON DEMANDED SHE DRIVE HIM IN HER VEHICLE. PRICE STATED WHEN THEN WERE IN THE VEHICLE, JOHNSON CONTINUED TO POINT THE WEAPON AT HER AND DEMANDED SHE DRIVE AWAY. PRICE STATED THAT IS WHEN MAYES ARRIVED ON SCENE. PRICE STATED MAYES APPROACHED THE VEHICLE AND JOHNSON BEGAN SHOOTING AT MAYES, STRIKING HIM IN THE NECK. PRICE STATED JOHNSON THEN FLED ON FOOT PRIOR TO OFFICERS ARRIVAL. OFFICERS SECURED THE AREA AND A NORTHWEST SUPERVISOR, MAJOR CRIMES DETECTIVES, AND CRIME SCENE PERSONNEL ARRIVED ON SCENE. ONCE THE INVESTIGATION WAS COMPLETE, THE VEHICLE WAS TOWED TO THE CRIME SCENE BAY AND OFFICERS WERE ADVISED MAYES APPEARED TO BE IN CRITICAL CONDITION. BWC IN USE.
