**NARRATIVE**

**NARRATIVE**

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A THEFT CALL. PRIOR TO ARRIVAL, OFFICERS WERE ADVISED THE VICTIM, PATRICK BROWN WAS BLEEDING FROM THE HEAD. OFFICERS RESPONDED CODE 3. UPON ARRIVAL, OFFICERS MADE CONTACT WITH STAFF MEMBER OF THE BUSINESS, ZANDRIA FULLYLOVE. MS. FULLYLOVE ADVISED MR. BROWN WAS INVOLVED IN A PHYSICAL ALTERCATION AND THE SUSPECTS THAT CAUSED INJURY TO MR. BROWN FLED THE SCENE IN VEHICLE 1 LAST SEEN GOING NORTHBOUND ON GEYER SPRINGS ROAD. MS. FULLYLOVE PROVIDED A PICTURE OF THE LICENSE PLATE OF VEHICLE 1 TO OFFICERS VIA PHONE. OFFICERS OBSERVED SHATTER GLASS ON THE GROUND OF THE PARKING LOT WHICH MS. FULLYLOVE ADVISED IT WAS INVOLVED IN THE INCIDENT THAT OCCURRED. OFFICERS IMMEDIATELY PERFORMED A BROADCAST OF VEHICLE 1 AND LAST DIRECTION IT WAS TRAVELING. BROWN ADVISED HE DOES NOT WANT TO GO TO THE HOSPITAL. MR. BROWN ADVISED HE WAS ADVISED BY ONE OF HIS COWORKERS THAT THREE INDIVIDUALS WERE STEALING THE LISTING PROPERTY. MR. MR. BROWN ADVISED HE CONFRONTED THE THREE SUBJECTS IN THE PARKING LOT. MR. BROWN ADVISED WHEN HE CONFRONTED THE THREE SUBJECTS THEY GOT UPSET AND GOT INTO A PHYSICAL ALTERCATION WITH THEM. MR. BROWN ADVISED THE BLACK MALE SUBJECT HAD HIM IN A HEADLOCK. MR. BROWN FURTHER ADVISED ONE OF THE BLACK FEMALE SUBJECTS WENT TO THE TRUCK OF VEHICLE 1 TO RETRIEVE A MASON JAR. MR. BROWN ADVISED WHILE HE WAS STILL IN A PHYSICAL ALTERCATION WITH THE OTHER TWO SUBJECTS ONE OF THE BLACK FEMALE SUBJECTS CAME UP TOWARDS HIM AND SMASHED THE MASON DRIVE ON TOP OF HIS HEAD CAUSING INJURY. MR. BROWN FURTHER ADVISED HE GOT HIS OWN KNIFE AND SLASHED THE LEFT REAR TIRE OF VEHICLE 1.

OFFICERS MADE CONTACT AND TOOK STATEMENTS FROM MS. EVANS AND LAWRENCE JENKINS DUE TO THEM BEING WITNESS OF THE INCIDENT. MS. EVANS AND MR. JENKINS BOTH ADVISED THEY OBSERVED MR. BROWN IN A PHYSICAL ALTERCATION. BOTH MR. JENKINS AND MR. THEY ATTEMPTED TO ASSIST MR. BROWN. BOTH MR. JENKINS AND MS. EVANS ADVISED THEY OBSERVED ONE OF THE BLACK FEMALES HAVING A KNIFE ATTEMPTING TO HIT MR. BROWN WITH A KNIFE. MR.
