OFFICERS OBSERVED THE MEDICAL AND RESCUE TEAMS WORKING ON AN UNIDENTIFIED BLACK MALE. OFFICERS WERE INFORMED BY A CREW MEMBER FROM TRUCK 10 THAT THE INDIVIDUAL HAD A LACERATION ON THE BACK OF HIS NECK.
