## **NARRATIVE**

ON WEDNESDAY, OCTOBER 30, 2024, AT APPROXIMATELY 1317 HOURS, NORTHWEST PATROL OFFICERS RESPONDED TO 11311 MARA LYNN ROAD ABOUT A SUSPICIOUS PERSON CALL FOR SERVICE. UPON ARRIVAL, OFFICERS LOCATED TOMMY FORREST (B/M, 12/06/1954), APPARENTLY DECEASED IN A POOL OF BLOOD. BLOOD WAS POOLED ABOVE MR. FORREST'S UPPER TORSO AND HEAD. OFFICERS WERE NOT ABLE TO DETERMINE THE CIRCUMSTANCES SURROUNDING THE INCIDENT. HOMICIDE DETECTIVES WERE NOTIFIED TO RESPOND TO THE SCENE.

DETECTIVES ARRIVED ON THE SCENE AND BEGAN THE PRELIMINARY INVESTIGATION. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND VIDEO SURVEILLANCE FOOTAGE. NO INFORMATION WAS PROVIDED REGARDING MR. FORREST'S CONDITION. DUE TO THE UNKNOWN CIRCUMSTANCES AND THE POSSIBILITY OF FOUL PLAY, DETECTIVES SECURED THE SCENE PENDING ANY FURTHER INVESTIGATIONS AND PROCESSING, PENDING A SEARCH AND SEIZURE WARRANT.

A SEARCH AND SEIZURE WARRANT WAS ISSUED AND CRIME SCENE AND DETECTIVES PROCESSED THE APARTMENT. NO VISIBLE INJURIES WERE NOTED ON MR. FORREST. THE PULASKI COUNTY CORONER RESPONDED AND TOOK POSSESSION OF MR. FORREST. AT THIS TIME THE CAUSE OF DEATH IS UNDETERMINED. A FULL AUTOPSY WILL BE COMPLETED TO DETERMINE THE CAUSE OF DEATH.
