UPON ARRIVAL, OFFICERS LOCATED JERRICK HOLDEN (B/M; 09/19/1979) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED, HOWEVER, MR. HOLDEN WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE AND WITNESSES. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. HOLDEN FOR AN AUTOPSY. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
