**NARRATIVE**

ON 01/25/2025 AT APPROXIMATELY 1724 HOURS, I, OFFICER SALE, RESPONDED TO UAMS EMERGENCY ROOM AT 4301 W MARKHAM ST FOR A BATTERY REPORT. UPON ARRIVAL, I MADE CONTACT WITH CISILY VASQUEZ AND SCOTTIE FLIPPO.

FLIPPO HAD A SMALL CUT ON HIS LEFT CHEEK, A STREAK OF BLOOD GOING ACROSS HIS FACE AND A RED BRUISE ON THE BACK OF HIS LEFT EAR. FLIPPO ADVISED HE AND HIS FIANCÉ WERE STAYING AT 815 WRIGHT ST AT A FRIEND'S, SHAKAYLA BOYD, HOME FOR A FEW NIGHTS. FLIPPO ADVISED HE AND VASQUEZ WERE IN THE BEDROOM WORKING ON COLLEGE HOMEWORK WHEN SIDNEY MAYO, THE FATHER OF BOYD'S CHILD, RIPPED THE BEDROOM DOOR OPEN AND POINTED A GUN AT FLIPPO. FLIPPO ADVISED HE PUT HIS HANDS UP AND MAYO ASKED HIM, "WHAT'S YOUR PROBLEM?" FLIPPO ADVISED THAT MAYO APPROACHED HIM AND PISTOL WHIPPED HIM WITH WHAT FLIPPO BELIEVES WAS A 9MM BLACK HANDGUN. FLIPPO ADVISED MAYO HAD THEN KICKED AND PUNCHED HIM IN THE FACE. FLIPPO ADVISED MAYO GRABBED HIM BY THE STRAP OF HIS OVERALLS AND DRAGGED FLIPPO OUTSIDE THE RESIDENCE WITH THE GUN PUSHED UP AGAINST THE BACK OF FLIPPO'S HEAD. FLIPPO ADVISED DURING THIS TIME MAYO TOLD HIM THAT "IF HE MOVES", MAYO WOULD "TAKE THAT AS A SIGN OF AGGRESSION AND BLOW HIS BRAINS OUT." FLIPPO ADVISED MAYO KEPT TELLING HIM TO BEG FOR HIS (FLIPPO'S) LIFE. VASQUEZ ADVISED SHE APPROACHED MAYO TO ATTEMPT TO STOP HIM AND CALM HIM DOWN, BUT MAYO THEN POINTED THE GUN AT HER. VASQUEZ ADVISED MAYO KEPT SAYING HE WAS TOLD SOMETHING DIFFERENT. VASQUEZ ADVISED THAT AFTER MAYO LEFT THE LOCATION, BOYD HAD SHOWED VASQUEZ TEXT MESSAGES BETWEEN BOYD AND MAYO. VASQUEZ ADVISED THE TEXT MESSAGES FROM BOYD ADVISED FLIPPO WAS CALLING VASQUEZ A BITCH AND THAT FLIPPO HAD PHYSICALLY BEAT UP VASQUEZ. ## NARRATIVE

OFFICERS RESPONDED TO TACO BELL, LOCATED AT 4424 WEST MARKHAM STREET, IN RELATION TO WHAT WAS DISPATCHED AS A ROBBERY OF A BUSINESS CALL, REPORTED BY MR. WAGONER. COMMUNICATIONS ADVISED MR. WAGONER STATED A BLACK MALE WITH A HANDGUN DEMANDED MONEY FROM THE SAFE AT TACO BELL.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. WAGONER. MR. WAGONER ADVISED HE WAS ARRIVING AT WORK AT TACO BELL, THE SUSPECT DEMANDED THAT HE USE HIS KEYS TO UNLOCK THE SAFE AND PRESENTED HIS HANDGUN UNDER HIS ARM. MR. WAGONER TOLD THE SUSPECT HE DID NOT HAVE A KEY AND WAS WAITING ON THE STORE MANAGER WITH THE KEYS. MR. WAGONER TRIED TO USE HIS PHONE TO CALL 911 THROUGH SIRI. THE SUSPECT ASKED MR. WAGONER WHO HE WAS TEXTING AND THEN DEMANDED HIM GIVE HIM HIS PHONE TO VERIFY HE WAS NOT TEXTING OR CALLING 911. THE SUSPECT THEN TOOK POSSESSION OF MR. WAGONERS PHONE TO MAKE SURE HE DID NOT CALL POLICE, THEN SUSPECT GAVE THE PHONE BACK. THE SUSPECT THEN LEFT THE AREA BEHIND THE BUSINESS. MR. WAGONER SAID IT LOOKED LIKE HE GOT IN A SILVER NISSAN ALTIMA WITH DARK TINTED WINDOWS AND LEFT THE SCENE. HE ADVISED IT WAS LAST SEEN HEADING NORTH ON WALNUT DRIVE. MR. WAGONER DESCRIBED THE SUSPECT AS A THIN BLACK MALE WHO WAS APPROXIMATELY 5'08" WEARING ALL BLACK. OFFICERS HAVE RECENTLY HAD PREVIOUS INCIDENTS WHERE THE LISTED SUSPECTS PERFORMED SIMILAR ACTIONS AND HAD UTILIZED A SIMILAR VEHICLE.
