NARRATIVE

ON FRIDAY, FEBRUARY 21ST, 2025, AT APPROXIMATELY 1114 HOURS, OFFICERS RESPONDED TO A DISTURBANCE CALL FOR SERVICE 311 E. 8TH STREET (CUMBERLAND TOWERS) IN APARTMENT 401. UPON ARRIVAL, OFFICERS WERE DIRECTED TO MAKE CONTACT WITH A SUBJECT IN APARTMENT 401 WHO WAS REFUSING TO LEAVE THE PREMISES. OFFICERS RESPONDED TO APARTMENT 401 AND MADE CONTACT WITH SHANNON BROWN (B/M; 12/11/1984). OFFICERS OBSERVED APPARENT BLOOD ON MS. BROWN'S PERSON AND LOCATED ROBERT JOHNSON (B/M; 06/20/1964) SUFFERING FROM AN UNKNOWN SEVERE INJURY. MEMS AND RESCUE RESPONDED AND ATTEMPTED LIFE-SAVING MEASURES, HOWEVER, MR. JOHNSON WAS PRONOUNCED DECEASED ON SCENE. MS. BROWN WAS DETAINED AND TRANSPORTED TO MAJOR CRIMES FOR FURTHER INVESTIGATION. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASED THE AREA FOR SURVEILLANCE AND WITNESSES. MS. BROWN WAS DEVELOPED AS A SUSPECT IN THIS INCIDENT. SHE WAS SUBSEQUENTLY CHARGED WITH CAPITAL MURDER AND TRANSPORTED TO PCRJ WITHOUT INCIDENT. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TRANSPORTED MR. JOHNSON FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
