MAHAN STATED HE DID NOT REMEMBER THE OTHER B/M'S NAME AND STATED HE DID NOT DO ANYTHING TO HIM WHEN SUSP#1 POINTED THE GUN. MAHAN STATED SUSP#1 WAS ABOUT 25-30 YRS OLD AND HE WAS BETWEEN 5'6 AND 5'8 AND ABOUT 150 LBS. HE STATED HE WAS DARK SKINNED AND HAD DREADS, WEARING ALL BLACK CLOTHING. MAHAN ADVISED THE RIGHT REAR WINDOW IS BROKEN OUT AND THERE IS PLEXI-GLASS ON IT WITH LARGE GOLD WRITING. THERE IS ALSO DAMAGE TO THE BACK BUMPER. A BROADCAST WAS MADE AND DET. HARMON WAS CONTACTED AND INTERVIEWED MAHAN. NO MVR WAS IN USE.

NARRATIVE

OFFICERS RESPONDED TO THE ABOVE LISTED ADDRESS FOR A ROBBERY ALARM.

ON ARRIVAL, OFFICERS SPOKE WITH BRIJESH MODI, WHO STATED THAT WHILE HE WAS AT WORK, A RED CHRYSLER PARKED IN THE DRIVEWAY IN FRONT OF THE STORE INSTEAD OF IN A PARKING SPOT. HE STATED THAT AN UNKNOWN B/M WALKED INTO THE STORE FROM THE CAR, AND HE TOLD HIM TO MOVE HIS VEHICLE TO A SPOT AND THAT CAUSED AN ARGUMENT BETWEEN THE TWO. EVENTUALLY, THE B/M ATTEMPTED TO BUY SOME ALCOHOL, BUT HE WAS REFUSED DUE TO NOT HAVING HIS ID ON HIM. MODI STATED THAT THIS MADE THE B/M MAD TOO, BUT HE EVENTUALLY HAD HIS GIRLFRIEND BUY IT.

AFTER PURCHASING A BOTTLE OF CIROC, THE B/M TOLD MODI HE WANTED TO TRADE IT FOR ANOTHER FLAVOR AND MODI TOLD HIM HE CAN'T DO THAT. AFTER THAT, THE B/M GOT MAD AND WALKED BEHIND THE COUNTER AND GRABBED THE ONE HE WANTED OFF THE SHELF AND TRIED TO PUT THE ONE HE BOUGHT IN ITS PLACE. MODI STEPPED BETWEEN THE B/M AND THE EXIT AND HE GRABBED THE BOTTLE AND THEY FOUGHT OVER IT FOR A SECOND BUT MODI MANAGED TO GET IT AWAY FROM HIM. THE B/M THEN GRABBED THE BOTTLE HE ORIGINALLY BOUGHT AND STARTED LEAVING THE STORE WHILE MODI ESCORTED HIM OUT. THE TWO GOT INTO ANOTHER ARGUMENT AT THE DOOR AND THE B/M STRUCK MODI IN THE HEAD WITH THE BOTTLE AND THEN FLED THE SCENE.

OFFICERS WATCHED THE SECURITY CAMERA FOOTAGE OF THE INCIDENT.

OFFICERS ISSUED MODI AN INCIDENT CARD AND TOLD HIM THAT DETECTIVES WOULD BE IN TOUCH WITH HIM.

A BROADCAST WAS NOT CONDUCTED DUE TO A LACK OF INFORMATION ON THE SUSPECT.
