NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A ROBBERY OF AN INDIVIDUAL. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE VICTIM, MARGARITA GUTIERREZ. MS. M. GUTIERREZ ONLY SPEAKS SPANISH, SO HER DAUGHTER, ERENDIDA GUTIERREZ TRANSLATED FOR HER.

MS. M. GUTIERREZ WOULD ADVISE SHE WAS SITTING DOWN INSIDE OF THE BUSINESS, WHEN AN UNKNOWN MALE WALKED INSIDE THROUGH THE FRONT DOOR. MS. M. GUTIERREZ ADVISED THE MALE WAS WEARING DARK CLOTHING AND WAS A HISPANIC MALE. THE MALE WOULD BEGIN SPEAKING TO MS. M. GUTIERREZ IN SPANISH, DEMANDING MONEY FROM HER. MS. M. GUTIERREZ HAD HER IPHONE IN HER HAND, WHICH HE GRABBED OUT OF HER HAND. HE THEN DISPLAYED A BLACK HANDGUN AND BEGAN LEADING MS. M. GUTIERREZ BEHIND THE COUNTER AND CONTINUED DEMANDING MONEY. THE SUSPECT WOULD TAKE POSSESSION OF MS. M. GUTIERREZ'S WALLET AND REMOVE THE CASH THAT WAS INSIDE. HE WOULD THEN TAKE TWO RINGS AND TWO BRACELETS OFF OF MS. M. GUTIERREZ THAT SHE WAS ACTIVELY WEARING. AFTER TAKING THE ITEMS, THE SUSPECT WOULD LEAVE OUT OF THE BACK DOOR AND THEN FLEE ON FOOT, GOING EAST ON CARLYLE DRIVE.

OFFICERS WOULD PUT OUT AN INITIAL BROADCAST STATING THE SUSPECT WAS A HISPANIC MALE WITH DARK CLOTHING AND WOULD DIRECT OTHER OFFICERS TO 8501 DREHER LANE, AS MS. M. GUTIERREZ'S PHONE WAS PINGING TO THIS LOCATION.

WHEN OFFICERS ARRIVED AT 8501 DREHER LANE, THEY FOUND MR. PEREZ WALKING AROUND WEARING DARKER CLOTHING. HE WAS DETAINED AND IDENTIFIED BY OFFICERS, BUT WOULD BE RELEASED AS OFFICERS LACKED ADDITIONAL EVIDENCE TO MAKE A PROBABLE CAUSE ARREST. OFFICERS WERE ABLE TO RECOVER MS. M. GUTIERREZ'S PHONE NEAR 8501 DREHER LANE.

ROBBERY DETECTIVES WOULD RESPOND TO THE SCENE AND TAKE A STATEMENT FROM MS. M. GUTIERREZ. AFTER MS. GUTIERREZ'S PHONE WAS PROCESSED BY THE CSSU, IT WAS RETURNED TO HER.

OFFICERS WERE ABLE TO WATCH VIDEO FOOTAGE OF THE INCIDENT AND GAVE A MORE ACCURATE DESCRIPTION OF THE SUSPECT IN A BROADCAST. THE SUSPECT WAS WEARING A BLUE NIKE HOODIE THAT SAID "WARRIOR TENNIS WITH THE HOOD RAISED AND BLACK PANTS. HE WAS ALSO WEARING BLUE LATEX GLOVES, AS WELL AS A BLACK BANDANA TO COVER HIS LOWER FACE AND SUNGLASSES COVERING HIS EYES.

THE INVESTIGATION IS ONGOING. BWC IN USE
