NARRATIVE

ON THE 23RD OF APRIL, 2025, AT APPROXIMATELY 1759 HOURS, OFFICERS WERE DISPATCHED TO 9203 CHICOT ROAD (FAST MART) IN REFERENCE TO A BATTERY CALL.

CONTACT WAS MADE WITH MR. MARIO CHOC, WHO STATED HE WAS SITTING DOWN ON A CURB, IN THE PARKING LOT OF THE BUSINESS. MR. CHOC STATED HE WAS APPROACHED BY A BLACK MALE INDIVIDUAL WHO WAS WEARING A WHITE MUSCLE SHIRT AND A LIGHT-COLORED COWBOY HAT. MR. CHOC STATED THE SUSPECT TOLD HIM TO GIVE HIM HIS PHONE. MR. CHOC STATED THE SUSPECT PULLED A BLACK HANDGUN FROM HIS WAISTBAND AND POINTED IT AT HIM. MR. CHOC STATED THE SUSPECT PUNCHED THE LEFT SIDE OF HIS FACE WITH HIS RIGHT HAND, KNOCKING HIM DOWN. MR CHOC STATED THE SUSPECT REACHED IN HIS POCKET AND TOOK HIS CELL PHONE.

MANUEL MENDEZ WHO IS A FAST MART EMPLOYEE ADVISED HE CAPTURED SECURITY FOOTAGE OF THE INCIDENT. THE FOOTAGE SHOWS THE SUSPECT APPROACH MR. CHOC AND REACH FOR SOMETHING IN HIS WAISTBAND. HOWEVER, MR. CHOC WAS SITTING JUST OUTSIDE OF FRAME OF THE CAMERA AND DID NOT CAPTURE THE ACTUAL INCIDENT. THE SUSPECT CAN BE SEEN WALKING AWAY NORTHBOUND ON CHICOT ROAD.

MR. CHOC HAD INJURY TO HIS FACE BUT REFUSED MEDICAL ATTENTION. A BROADCAST IN REFERENCE TO THE ROBBERY WAS MADE. MR. CHOC STATED HE COULD NOT REMEMBER HIS ADDRESS AND THAT IS WHY IS NOT LISTED IN THIS REPORT. MR. CHOC WAS PROVIDED WITH HIS INCIDENT NUMBER. MVR AND BWC WERE IN USE.
