## **NARRATIVE**

ON SATURDAY, MAY 3, 2025, AT APPROXIMATELY 1738 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED AT THE LOCATION OF 3010 S. CROSS STREET. UPON OFFICERS ARRIVAL, THEY LOCATED A MALE VICTIM, LATER IDENTIFIED AS SERGIO TONEY (B/M 06/18/2003), INSIDE THE RESIDENCE, SUFFERING FROM APPARENT GUNSHOT WOUND. OFFICERS SECURED THE SCENE AND NOTIFIED MEMS TO RESPOND. MEMS ARRIVED AND BEGAN LIFE SAVING MEASURES, BUT MR. TONEY SUCCUMBED TO HIS INJURIES ON SCENE. OFFICERS THEN BEGAN RECEIVING ADDITIONAL INFORMATION THAT OTHER GUNSHOT VICTIMS WERE ARRIVING AT SURROUNDING HOSPITALS. OFFICERS MADE CONTACT WITH DEMARIO HARVEY AND JASON DAVIS AT UAMS WHO BOTH WERE SUFFERING FROM APPARENT GUNSHOT WOUNDS. OFFICERS RESPONDED TO CHILDREN'S HOSPITAL AND MADE CONTACT WITH BRODY HILL WHO WAS SUFFERING FROM AN APPARENT GUNSHOT WOUND. OFFICERS SECURED ALL SCENES. HOMICIDE AND CSSU WERE NOTIFIED TO RESPOND.

HOMICIDE DETECTIVES ARRIVED ON SCENE AND BEGAN THE PRELIMINARY INVESTIGATION. DETECTIVES CANVASSED THE AREA AND MADE CONTACT WITH WITNESSES. DETECTIVES OBTAINED A SEARCH WARRANT FOR THE RESIDENCE AT 3010 S. CROSS STREET.

THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO 3010 S. CROSS STREET AND RETRIEVED MR. TONEY'S BODY. THE CORONERS WILL SUBMIT MR. TONEY TO THE CRIME LAB FOR AN AUTOPSY. THE NEXT OF KIN, MS. JORDAN, WAS NOTIFIED OF THIS INCIDENT. INVESTIGATION IS ONGOING.
