NARRATIVE

OFFICERS RECEIVED A CALL TO THE LISTED ADDRESS FOR A ROBBERY OF AN INDIVIDUAL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. RAYMOND JOHNSON, WHO ADVISED HE WAS INSIDE THE STORE PURCHASING LOTTERY TICKETS AND CIGARETTES. MR. JOHNSON NOTICED AN UNIDENTIFIED BLACK MALE ENTER THE STORE AND JUST STAND BEHIND HIM. AS MR. JOHNSON WAS COUNTING OUT MONEY TO THE CLERK, THE UNKNOWN BLACK MALE PUSHED HIM, KNOCKING HIM OFF BALANCE AND ONTO THE COUNTER. THE BLACK MALE THEN USED HIS HAND TO GO INSIDE MR. JOHNSON'S LEFT POCKET AND TOOK APPROXIMATELY \$3,800 IN CASH BEFORE PROCEEDING TO RUN OUT THE DOOR.

OFFICERS THEN SPOKE WITH THE STORE CLERK, MR. KYUNG HYON, WHO OBSERVED THE ROBBERY TAKE PLACE. AFTER THE UNIDENTIFIED BLACK MALE FLED, MR. HYON RAN BEHIND HIM TO SEE WHICH DIRECTION HE WAS RUNNING, AND HE FLED INTO A NEARBY NEIGHBORHOOD NEAR THE STORE (AZALEA DR.).

OFFICERS WERE ABLE TO VIEW THE VIDEO FOOTAGE. THEY THEN NOTIFIED A MAJOR CRIME DETECTIVE, WHO RESPONDED TO THE SCENE TO OBTAIN A COPY OF THE VIDEO FOOTAGE AND TO INTERVIEW BOTH THE VICTIM AND THE WITNESS. OFFICERS THEN CIRCULATED THE NEARBY NEIGHBORHOOD TO SEARCH FOR THE UNIDENTIFIED BLACK MALE, WITH NEGATIVE RESULTS. MR. JOHNSON WAS PROVIDED WITH AN INCIDENT REPORT NUMBER. MR. BWC WAS IN USE.
