NARRATIVE

ON MAY 30, 2025, I, OFFICER RICHARDSON, WAS ON SCENE ON A DISTURBANCE WITH A WEAPON AT 9600 WEST 36TH STREET WHEN OFFICERS COULD HEAR ANOTHER DISTURBANCE WHILE WRAPPING UP THE ORIGINAL CALL. OFFICERS OBSERVED THE ORIGINAL CONTACT, WILLIAMS, BEING INJURED. OFFICERS MADE CONTACT WITH WILLIAMS.

WILLIAMS STATED AFTER HE WAS DROPPED OFF AT HIS VEHICLE BY OTHER OFFICERS, HE WAS JUMPED AFTER THEY HAD LEFT. OFFICERS OBSERVED ABRASIONS ON HIS FACE, BOTH SIDES OF THE HEAD, ON BOTH ARMS, LEFT THUMB, AND BRUISES ON HIS BACK. WILLIAMS STATED THE UNKNOWN BLACK MALE SUBJECT TOOK HIS PHONE WITH FORCE STATING "BITCH, I'M GOING TO BEAT YOU WITH YOUR OWN PHONE." OFFICERS ASKED WILLIAMS IF HE WANTED TO BE CHECKED OUT BY MEMS AND HE STATED YES. OFFICERS REQUESTED MEMS. OFFICERS BROADCASTED A ROBBERY OF AN INDIVIDUAL BOLO FOR THE DESCRIPTION OF THE UNKNOWN BLACK MALE. OFFICERS' SUPERVISOR CONTACTED MAJOR CRIMES. OFFICERS BROUGHT WILLIAMS TO THE OLD ALE SCHOOL ON BRYANT STREET. OFFICERS GATHERED WILLIAMS PERSONAL BELONGINGS FROM THE PARKING LOT AND SECURED HIS VEHICLE.

NARRATIVE

NARRATIVE

OFFICERS INTERVIEWED MR. BALENTINE AT THE SCENE. HE STATED THAT HE HAD BEEN SHOT IN FRONT OF THE APARTMENT COMPLEX LOCATED AT 1502 GREEN MOUNTAIN DRIVE. HE DESCRIBED THE SHOOTER AS A LIGHT-SKINNED BLACK MALE WITH SHORT HAIR. MR. BALENTINE FURTHER ADVISED THAT AFTER BEING SHOT, HE FLED THE LOCATION AND RAN TO HIS COUSIN'S APARTMENT, LOCATED AT 1502 GREEN MOUNTAIN DRIVE, APARTMENT #153. OFFICERS PROVIDED A BOLO OF THE POSSIBLE SUSPECT. OFFICERS CIRCULATED THE AREA FOR THE UNKNOWN SUSPECT WITH NEGATIVE RESULTS.

OFFICERS IDENTIFIED MR. BALENTINE COUSIN AS MS. ANAYA PRICE. MAJOR CRIMES WAS NOTIFIED, AND CRIME SCENE PERSONNEL WERE REQUESTED TO RESPOND TO THE LOCATION.

OFFICERS CLEARED THE SCENE WITHOUT FURTHER INCIDENT. MOBILE VIDEO RECORDER (MVR) AND BODY-WORN CAMERA (BWC) WERE IN USE DURING THE INCIDENT.

NARRATIVE
