OFFICERS ALSO OBSERVED A SILVER HONDA ACCORD WHICH HAD 1 BULLET HOLE IN THE FRONT PASSENGER SIDE WINDSHIELD, 1 BULLET HOLE IN THE HOOD ON THE DRIVER SIDE. AND ANOTHER BULLET HOLE IN THE DRIVER SIDE WINDOW. OFFICERS OBSERVED A WHITE LEXUS SEDAN THAT HAD A BULLET HOLE IN THE HOOD ON THE DRIVER SIDE. MS. J1 WAS SHOT IN THE RIGHT SIDE OF THEIR CHEST. MS. MONICA EGESTON, MOTHER, GRABBED J1 AND PUT THEM IN VEHICLE 4. SHE DROVE TO A LOCAL HOSPITAL FOR MEDICAL TREATMENT. THEY LEFT THE RESIDENCE PRIOR TO OFFICERS ARRIVAL. VEHICLE 4 HAD MULTIPLE BULLET HOLES IN IT. J1 WAS REPORTED TO BE IN STABLE CONDITION.

OFFICERS OBSERVED ON VIDEO FOOTAGE J1 AND J2 STANDING OUTSIDE NEAR THE BBQ GRILL AND ALL OF THE SUDDEN RUN INSIDE THE RESIDENCE ONCE SHOTS ARE FIRED.

MULTIPLE VEHICLES WERE STRUCK FROM THE INCIDENT. VEHICLE 2,3 AND 4 WERE STRUCK BY GUNFIRE.

J3 ADVISED J1 HAD BEEN HAVING ISSUES WITH MR. QUADAURISE DUNN. THEY ADVISED J1 WAS AFFILIATED WITH THEIR GANG AND HAS STOPPED HANGING OUT WITH THEM.

OFFICERS LOCATED SHELL CASINGS AND A CELL PHONE IN THE STREET AROUND THE 4000 BLOCK OF MALLOY.

SGT. CRAWFORD WAS ADVISED AND RESPONDED. CSSU AND DETECTIVES RESPONDED TO PROCESS THE SCENE.
