OFFICERS RESPONDED TO THE PARKING LOT OF THE PULASKI COUNTY JUVENILE DETENTION FACILITY FOR THE REPORT OF A ROBBERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH DONALD BRATTON, WHO WAS LAYING ON THE GROUND BLEEDING PROFUSELY FROM HIS FACE. BRATTON STATED AN UNKNOWN BLACK MALE, LATER IDENTIFIED AS ZEBODEE BORUM, CAME TO HIS VEHICLE, 2006 TAN NISSAN FRONTIER (AR LPN:BEU94P VIN:1N6AD07U46C476144), FOUGHT HIM IN THE DRIVER COMPARTMENT OF THE VEHICLE, THREW HIM OUT OF THE DRIVER SEAT, AND TOOK OFF IN THE VEHICLE WITH BRATTON STILL ATTACHED TO THE VEHICLE BY THE SEATBELT BRATTON COULD NOT ADVISE THE DIRECTION OF TRAVEL FOR HIS VEHICLE. MEMS AND RESCUE RESPONDED TO THE LOCATION. MEMS TRANSPORTED BRATTON TO UAMS FOR HIS INJURIES. AT UAMS, OFFICERS WERE ADVISED BRATTON HAD SUFFERED A BRAIN BLEED.

WHILE STILL ON SCENE WITH BRATTON, COMMUNICATIONS STATED A VEHICLE MATCHING THE DESCRIPTION OF VEHICLE 1 WAS SEEN CRASHED INTO A HOUSE AT 16TH STREET AND FAIRPARK AVENUE. OFFICERS RESPONDED TO THE AREA AND FOUND BORUM LAYING IN THE YARD AT 1506 SOUTH TAYLOR STREET. OFFICERS COULD SMELL THE ODOR OF INTOXICANTS ON BORUM'S PERSON. BORUM WAS PLACED IN A PATROL VEHICLE. MEMS RESPONDED FOR BORUM DUE TO AN ACCIDENT. OFFICERS ATTEMPTED TO MAKE CONTACT WITH THE RESIDENT NATHANIEL DAILY AT 1600 FAIRPARK, WITH NEGATIVE RESULTS, DUE TO THE VEHICLE RUNNING INTO THE HOUSE. SERGEANT RUFF AND MAJOR CRIMES DETECTIVES WERE NOTIFIED. THEY RESPONDED TO THE SCENE. AN INVENTORY OF THE VEHICLE WAS CONDUCTED. THE VEHICLE WAS TOWED TO CITY IMPOUND PER POLICY.

DUE TO THE HIGH LEVEL OF INTOXICATION, OFFICERS WERE UNABLE TO PERFORM A STANDARDIZED FIELD SOBRIETY TEST ON BORUM. BORUM STATED HE WOULD REFUSE A BREATH TEST AND WOULD NOT PROVIDE A URINE SAMPLE. BORUM REFUSED TO SIGN THE ACT 106 RIGHTS FORM. OFFICERS RAN BORUM FOR WARRANT AND FOUND TO HAVE A SUSPENDED LICENSE.

BORUM WAS CHARGED WITH BATTERY 1ST, AGGRAVATED ROBBERY, UNAUTHORIZED USE OF ANOTHER PERSONS PROPERTY TO FACILITATE CRIME, THEFT OF PROPERTY, 2 COUNTS OF CRIMINAL MISCHIEF FIRST, DRIVING WHILE INTOXICATED, REFUSAL TO SUBMIT TO CHEMICAL TESTING, RECKLESS DRIVING, LEAVING THE SCENE OF AN ACCIDENT INVOLVING PROPERTY DAMAGE. AND DRIVING ON SUSPENDED LICENSE.
