## NARRATIVE

OFFICERS WERE DISPATCHED TO THE INCIDENT ADDRESS FOR A THEFT. OFFICERS MADE CONTACT WITH THE CLERK, MS. DARROUGH WHO ADVISED OFFICERS THAT TWO BLACK MALES CAME INTO THE STORE AND TOOK EIGHT, TWELVE PACKS OF BUD LIGHT BEER. MS. DARROUGH ADVISED WHEN SHE TRIED TO STOP SUSPECT ONE AND SUSPECT TWO FROM STEALING SHE WAS THREATEN BY THE SUSPECTS THAT SHE WOULD GET PUNCHED IN THE FACE IF SHE DID NO MOVE OUT OF THE DOORWAY. SHE ADVISED THAT SHE STEPPED OUT OF THEIR WAY. SHE STATED BOTH SUSPECTS EXITED THE STORE AND FLED IN VEH 1 IN UNKNOWN DIRECTION OF TRAVEL. OFFICER PROVIDED INCIDENT TO MS. DARROUGH AND A BROADCAST WAS MADE. 1L35 WAS NOTIFIED.

While officers were patrolling the area, real time crime center detectives advised of a vehicle that had been involved in a Robbery triggered the flock camera last seen heading southbound on 4800 Mabelvale Pike. The vehicle in question was a black Jeep Patriot bearing AR 304ULJ possibly occupied by two black males. One of the males involved was seen wearing a green reflective vest. While continuing to search the area, Officers observed the black Jeep Patriot stationary with a flat tire at 5400 W 49th Street with two black male subjects outside the vehicle. Officers conducted a felony take down and took both subjects into custody without incident. One of the subjects was identified as Donald Ray Sampson Jr (B/M DOB: 06/02/1975). The second subject was identified as Keith A. McFerguson (B/M DOB: 12/09/1961). Downtown Supervisor was advised of the incident and Major Crime Detectives were notified. Northwest officers attempted to make contact with the original victim of the incident but obtained negative results. While approaching the suspect vehicle, a green reflective vest was observed on the front driver seat area. A contract tow was requested to the location and the vehicle was taken to the crime scene bay to be further processed. Pictures of the vehicle and the suspects were forwarded to Major Crime Detectives. No other action was taken at this time. MVR and BWC in use.
