NARRATIVE

PERSON REPORTING (REFUSED) ADVISED THAT THEY HEARD SEVERAL GUN SHOTS NEAR THIS LOCATION BUT THEY DID NOT KNOW EXACTLY WHERE IT OCCURRED. WHILE PATROLLING THROUGH THE AREA, CONTACT WAS MADE WITH TYLER HENRY IN FRONT OF 9905 STARDUST TRAIL. HE ADVISED THAT SOMEBODY DROVE BY AND SHOT HIS HOUSE SEVERAL TIMES. HE SAID HIS COUSINS VICTIM 2 AND VICTIM 3 WERE IN THE HOUSE WITH HIM WHEN THE HOUSE GOT HIT. HE SAID NOBODY WAS HURT DURING THE SHOOTING. ALL THREE VICTIMS ADVISED THAT THEY WERE PLAYING A VIDEO GAME AND DID NOT SEE ANYTHING BUT THEY DID HEAR THE GUN SHOTS. SGT. MONROE WAS ADVISED OF THE INCIDENT. MAJOR CRIMES DETECTIVES WERE NOTIFIED ALONG WITH CRIME SCENE AND RESPONDED ON SCENE. APPROXIMATELY 14 SPENT CASINGS WERE LOCATED IN THE STREET IN FRONT OF 9905 STARDUST TRAIL.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN RESPONSE TO A BATTERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH SANDERS, GARNDER, AND JUV 1, WHO ALL HAD VISIBLE INJURIES. SANDERS ADVISED THEIR DOWNSTAIRS NEIGHBOR MET THEM OUTSIDE WITH APPROXIMATELY 9 OTHER BLACK FEMALES AND1 BLACK MALE AND JUMPED THEM. SANDERS AND GARDNER STATED ALL THE FEMALES WERE HITTING THEM. JUV 1 STATED THE BLACK MALE HIT HIM. SANDERS HAD BLOODY KNEES AND HAD MULTIPLE WOUNDS AROUND HER ANKLES. GARNDER HAD A BLOODY ELBOW. JUV 1 WAS STATING HE WAS HAVING SEVERE PAIN IN HIS RIBS. MEMS RESPONDED TO THE LOCATION. JUV 1 WAS TRANSPORTED TO CHILDREN'S HOSPITAL FOR ADDITIONAL TREATMENT.
