NARRATIVE

ON 06/05/2025, I, OFFICER WRIGHT RESPONDED TO THE LOCATION OF 8818 KANIS ROAD IN REFERENCE TO A SHOOTING AT THE LOCATION 500 NAPA VALLEY IN FRONT OF BUILDING 10.

OFFICERS MADE CONTACT WITH MR. DARMYRIUS RIVERS IN THE ABOVE LISTED VEHICLE WHO ADVISED HE HAD BEEN SHOT ONE TIME IN THE RIGHT LEG. OFFICERS THEN MADE CONTACT WITH MS. JAKERIA KELLY AND MR. RON KELLY WHO ALSO WERE IN THE ABOVE LISTED VEHICLE. ALL THREE VICTIMS ADVISED THEY DROVE FROM THE INCIDENT LOCATION OF 500 NAPA VALLEY TO THE LOCATION OF 8818 KANIS ROAD AND FLAGGED DOWN OFFICERS LOOKING FOR THE NEAREST HOSPITAL. DUE TO OFFICERS HANDLING ANOTHER CALL WITH MEMS UNIT 340, THEY ADVISED THEY WOULD TAKE THE VICTIM TO BAPTIST HEALTH EMERGENCY ROOM. A CRIME SCENE WAS THEN SET UP AT 8818 KANIS ROAD.

ONCE MEMS AND OFFICERS ARRIVED AT BAPTIST HOSPITAL, MR. RIVERS ADVISED THE ABOVE LISTED SUSPECT (WHICH IS HIS NEPHEW) AND HE HAD A FAMILY DISAGREEMENT AND ADVISED THE SUSPECT SHOT AT HIM AND THE TWO OTHER VICTIMS INSIDE THE VEHICLE WITH AN AR STYLE GUN AND THE BULLET HIT HIS RIGHT LEG THROUGH THE PASSENGER DOOR. THE ABOVE LISTED VEHICLE WAS OBSERVED TO HAVE A VISIBLE BULLET HOLE IN THE PASSENGER DOOR.

A SUPERVISOR, CSSU AND MAJOR CRIMES DETECTIVES WERE NOTIFIED AND RESPONDED TO BAPTIST TO SPEAK WITH THE VICTIMS. OFFICERS WERE ADVISED BY HOSPITAL PERSONNEL THAT MR. RIVERS WOULD NOT HAVE LIFE THREATENING INJURIES. A LETHALITY FORM AND LAURA'S CARD WAS PROVIDED TO MR. RIVERS AND OFFICERS LEFT THE HOSPITAL WITHOUT FURTHER INCIDENT.

A RIFLE SHELL CASING WAS RECOVERED AT THE INCIDENT LOCATION IN FRONT OF BUILDING 10 AND STORED AT THE NORTHWEST PROPERTY ROOM.
