NARRATIVE

AT APPROXIMATELY 0717 HOURS, I WAS DISPATCHED TO A CALL REGARDING CRIMINAL MISCHIEF AT THE RESIDENCE LOCATED AT 9208 TANYA DRIVE. WHILE ENROUTE, COMMUNICATIONS INFORMED US THAT BOTH A VEHICLE AND THE RESIDENCE HAD BEEN STRUCK BY GUNFIRE.

UPON ARRIVAL, I MADE CONTACT WITH JOHNNIE DAVIS, THE RESIDENT OF THE HOME. MR. DAVIS INFORMED OFFICERS THAT HE AND HIS WIFE, WILMER DAVIS, WERE SUDDENLY AWAKENED BY THE SOUND OF GUNFIRE DURING THE NIGHT. HE BELIEVED IT WAS BETWEEN 0200 AND 0230 HOURS WHEN HE WAS JOLTED AWAKE BY THE SHOTS.

JUST PRIOR TO CALLING THE POLICE, MR. DAVIS'S DAUGHTER, KENDRA CLARK, HAD ENTERED THE ROOM TO INFORM HIM THAT IT APPEARED HIS TRUCK (VEHICLE ONE) HAD BEEN STRUCK BY GUNFIRE. IT WAS AT THAT MOMENT HE DECIDED TO CONTACT LAW ENFORCEMENT.

OFFICERS ON SCENE WERE ABLE TO LOCATE AN ADDITIONAL BULLET HOLE IN VEHICLE TWO. FURTHERMORE, MULTIPLE SHELL CASINGS WERE FOUND IN THE ROADWAY. OFFICERS IMMEDIATELY SECURED THE SCENE TO PRESERVE THE EVIDENCE.

A SUPERVISOR FROM THE NORTHWEST DIVISION WAS CONTACTED REGARDING THE INCIDENT AND RESPONDED TO THE SCENE, WHICH PROMPTED THE RESPONSE OF DETECTIVES AND CRIME SCENE INVESTIGATORS. OFFICERS THEN PROCEEDED TO ENTER THE RESIDENCE WITH MR. DAVIS.

INSIDE, MR. DAVIS REPORTED THAT HIS GRANDCHILDREN, LISTED AS JUVENILES TWO THROUGH FIVE, AS WELL AS HIS WIFE, WILMER DAVIS, WERE PRESENT WHEN THE GUNFIRE STRUCK THE HOME, THANKFULLY, ALL OCCUPANTS REPORTED NO INJURIES FROM THE INCIDENT.

OFFICERS ALSO MADE CONTACT WITH KENDRA CLARK, WHO NOTED A BULLET HOLE NEAR THE WINDOW ABOVE THE BED WHERE SHE AND JUVENILE ONE WERE SLEEPING AT THE TIME OF THE GUNFIRE. KENDRA CONFIRMED THAT NEITHER SHE NOR JUVENILE ONE SUSTAINED ANY INJURIES. SHE ALSO MENTIONED THAT HER VEHICLE (VEHICLE TWO) HAD BEEN DAMAGED BY A BULLET. MR. DAVIS INDICATED THAT HIS TRUCK (VEHICLE ONE) HAD SUSTAINED MULTIPLE BULLET STRIKES DURING THE INCIDENT.

CRIME SCENE INVESTIGATORS RESPONDED TO PHOTOGRAPH THE AREA AND COLLECT ALL EVIDENCE. DETECTIVES ALSO ARRIVED TO INTERVIEW THE INVOLVED PARTIES.
