NARRATIVE

ON TODAYS DATE AT APPROXIMATELY 1122 I WAS DISPATCHED TO A DISTURBANCE AT 11214 MESA DRIVE APARTMENT H2. WHILE ENROUTE TO THIS LOCATION COMMUNICATIONS ADVISED A FIREARM WAS USED IN THIS DISTURBANCE.

UPON ARRIVAL, I MADE CONTACT WITH KNADIA LYNDSEY WHO STATED THAT HER EX-BOYFRIEND, KENYATTA NORWOOD, STAYED THE NIGHT AT HER APARTMENT AT 420 MARKHAM MESA PLACE APARTMENT K58 TO WATCH HER CAT. LYNDSEY SAID WHEN SHE RETURNED TO HER APARTMENT TODAY AFTER WORK, NORWOOD WAS ASKING TO GET BACK TOGETHER WITH HER AND SHE DID NOT WANT TO DISCUSS THIS SO SHE TOLD NORWOOD SHE WAS TAKING HIM BACK TO HIS RESIDENCE AT 4201 WEST 14TH STREET. LYNDSEY SAID AS SHE WAS DRIVING VEHICLE 1 EASTBOUND ON INTERSTATE 630, NORWOOD EXHIBITED ERRATIC BEHAVIOR AND BEGAN CHOKING HER. LYNDSEY SAID SHE IMMEDIATELY PULLED TO THE SHOULDER BETWEEN UNIVERSITY AND FAIR PARK. UPON STOPPING, NORWOOD PRODUCED A BROWN AND BLACK HANDGUN AND PLACED IT TO HER HEAD BEFORE STATING, "I'LL BLOW YOUR BRAINS OUT". LYNDSEY STATED SHE JUMPED OUT OF THE VEHICLE AND CALLED FAMILY TO TAKE HER HOME WHERE SHE CALLED POLICE. A LETHALITY FORM AND A LAURA'S CARD WERE COMPLETED WITH LYNDSEY.

DOWNTOWN OFFICERS WERE CIRCULATING THE AREA OF 4201 WEST 14TH STREET FOR VEHICLE 1 AND LOCATED IT IN THE AREA WITH THE KEYS IN IT. LYNDSEY MADE ARRANGEMENTS TO GET THE VEHICLE BACK. NORWOOD WAS NOWHERE AROUND THE VEHICLE WHEN IT WAS LOCATED. ROBBERY DETECTIVES WERE MADE AWARE OF THE CALL AND ADVISED THEY WOULD CONTACT LYNDSEY AT A LATER TIME. A COPY OF THE LETHALITY ASSESSMENT WAS ATTACHED TO THE RMS SYSTEM.

NARRATIVE

OFFICERS RESPONDED TO 16105 CHENAL PARKWAY FOR A POSSIBLE DISTURBANCE REPORT. OFFICERS MADE CONTACT WITH MS. SHELLANE KING. MS. KING INFORMED OFFICERS THAT A BLACK MALE WEARING ALL BLACK ATTEMPTED TO TAKE HER KEYS BY FORCE.

MS. KING STATED SHE HAD JUST ARRIVED TO WORK AT KROGER. AS SHE WAS GETTING OUT OF HER CAR PUTTING ON PERFUME, A BLACK MALE, WEARING A BLACK HOODIE AND BLACK PANTS, APPROACHED HER. HE TOLD HER TO GIVE HIM HER KEYS. SHE REFUSED AND HE BEGAN TO REACH FOR A GUN. SHE BEGAN "TUSSLING" WITH THE BLACK MALE. SHE THEN DROPPED HER KEYS. DURING THE STRUGGLE, MS. KING STATED THE BLACK MALE POINTED THE GUN AT HER AND HELD IT TO HER CHEST. THERE WERE NO SHOTS FIRED IN THE INCIDENT. MS. KING BEGAN YELLING AND OTHERS WERE ALERTED. THE BLACK MALE BEGAN RUNNING BACK EASTBOUND ON CHENAL. SOME OF THE OTHER EMPLOYEES ATTEMPTED TO CHASE HIM BUT WERE UNABLE TO CATCH HIM. HE WAS LAST SEEN EASTBOUND ON CHENAL PARKWAY BUT HE LOST SIGHT BEFORE HE RAN TO KANIS ROAD. MS. HANNA STOCKS STATED THE BLACK MALE APPROACHED HER WHILE SITTING IN HER VEHICLE AT WALK-ONS BEFORE HE APPROACHED MS. KING. MS. STOCKS STATED THE MALE ONLY ASKED HER A FEW QUESTIONS, ONE OF WHICH WAS IF SHE POSSESSED A GUN. SHE TOLD HIM TO LEAVE HER ALONE AND HE WALKED FURTHER TO KROGER.

OFFICERS WERE ABLE TO GET A BROADCAST OF THE SUBJECT OUT TO OTHER OFFICERS AND ATTEMPTED TO LOCATE HIM IN THE AREA BUT WERE UNABLE TO FIND ANYONE MATCHING THE DESCRIPTION. OFFICERS WERE ADVISED BY AN EMPLOYEE OF A LOCAL BUSINESS THE BLACK MALE WAS ALSO POSSIBLY WEARING RED GLOVES. THE PISTOL WAS DESCRIBED AS BLACK, POSSIBLY A GLOCK. MS. KING WAS PROVIDED THE INCIDENT NUMBER FOR THE CALL.
