NARRATIVE

ON SUNDAY, JUNE 8, 2025, AT APPROXIMATELY 2109 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE IN THE AREA OF WEST MARKHAM AND SOUTH UNIVERSITY AVENUE. UPON ARRIVAL, LOCATED ANTONIO SIMUEL (B/M 06/24/1988) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED AND TRANSPORTED MR. SIMUEL TO A LOCAL HOSPITAL WHERE HE WAS PRONOUNCED DECEASED. OFFICERS DETERMINED THAT THE INCIDENT OCCURRED AT THE LISTED ADDRESS AND THE SCENE WAS SECURED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. THE PULASKI COUNTY CORONERS OFFICER RESPONDED AND TOOK POSSESSION OF MR. SIMUEL FOR AN AUTOPSY.

DURING THE COURSE OF THE INVESTIGATION, AKILA DEWITT (B/F 11/20/1997) WAS DEVELOPED AS A SUSPECT IN THIS INCIDENT. MS. DEWITT WAS LOCATED AND TRANSPORTED TO MAJOR CRIMES FOR FURTHER INVESTIGATION. AFTER CONDUCTING A PRELIMINARY INVESTIGATION, MS. DEWITT WAS SUBSEQUENTLY CHARGED WITH CAPITAL MURDER AND TRANSPORTED TO PCRJ WITHOUT INCIDENT. THE NEXT KIN HAS BEEN NOTIFIED. THE INVESTIGATION IS ON-GOING.
