NARRATIVE

ON TUESDAY, JUNE 10TH, 2025, AT APPROXIMATELY 1054 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED KAYLA PAYNE (B/F; 07/04/2005) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED AND TRANSPORTED MS. PAYNE TO A LOCAL HOSPITAL, WHERE SHE WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE FOOTAGE AND WITNESSES. DURING THE COURSE OF THE INVESTIGATION, QURAN JOHNSON (B/M; 08/13/1996) WAS DEVELOPED AS A SUSPECT IN THIS INCIDENT. MR. JOHNSON WAS SUBSEQUENTLY ARRESTED AND CHARGED WITH CAPITAL MURDER. HE WAS TRANSPORTED TO PCRJ WITHOUT INCIDENT. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
