NARRATIVE

WHILE TRAVELING NORTH ON TAYLOR ST FROM 16 TH ST I OBSERVED A DISTURBANCE. I SEEN A WHITE MALE AND A BLACK MALE ARGUING. THE BLACK MALE WAS WALKING CLOSER TO THE WHITE MALE BEFORE THEY BOTH WENT OUT OF SIGHT BEHIND A BUSH. I DROVE CLOSER AND THAT IS WHEN THE BLACK MALE TOOK OFF RUNNING HEADED NORTH ON TAYLOR ST CROSSING OVER 12TH ST. I WAS UNSURE OF WHAT WAS GOING ON SO I DROVE BY WITH MY WINDOW DOWN AND THE WHITE MALE RAN UP TO ME ADVISING ME THAT THE SUBJECT STOLE HIS MONEY.

I DROVE AFTER THE SUSPECT WHO RAN TO THE APARTMENTS AT 1100 FAIR PARK BLVD. HE STOPPED AT THE STAIRS THEN REALIZED I WAS STILL FOLLOWING THEN TOOK OFF AGAIN. HE WAS PURSUED ALL THE WAY UP TO APARTMENT 41 WHERE HE RAN INSIDE AND SHUT THE DOOR. I FOLLOWED JUST AFTER HIM KICKING THE DOOR IN AND FOLLOWING AFTER. A BACKING OFFICER ARRIVED AND WE TOOK HIM INTO CUSTODY.

VICTIM WAS IDENTIFIED AS AVERY BAKER AND HE ADVISED THE SUSPECT (EDWARD WILLIAMS) REACHED INTO HIS POCKET DEMANDING MONEY AND TOOK \$280 IN ALL \$20 BILLS. HE ADVISED THIS OCCURRED AT 1400 FAIR PARK BUT HE FOLLOWED AFTER HIM TO 14TH AND TAYLOR WHICH IS WHEN I ARRIVED AND THE SUSPECT FLED. HE ADVISED HE WAS ON THE PHONE WITH HIS MOTHER ERICA BILELLO DURING THE WHOLE INCIDENT.

MR. BUFFINGTON STATED THE BLACK MALE OPENED HIS DOOR AND HAD PULLED A GUN OUT. MR. BUFFINGTON STATED THE BLACK MALE SUBJECT STATED TO GIVE HIM HIS WALLET. MR. BUFFINGTON STATED TO THE BLACK MALE SUBJECT HE DIDN'T HAVE TO DO THIS.

MR. BUFFINGTON STATED THE BLACK MALE SUBJECT WAS POINTING THE GUN AT HIM THE ENTIRE TIME. MR. BUFFINGTON STATED THE BLACK MALE SUBJECT HAD FIRED A SHOT INSIDE THE VEHICLE AND HITTING THE CENTER CONSUL, THEN POINTING THE GUN BACK AT MR. BUFFINGTON. MR. BUFFINGTON STATED ONCE THE BLACK MALE SUBJECT SHOT THE GUN, HE GAVE HIM HIS WALLET. MR. BUFFINGTON STATED THE BLACK MALE SUBJECT LEFT IN AN UNKNOWN DIRECTION OF TRAVEL. MR. BUFFINGTON STATED HE THEN DROVE DOWN TO THE WAFFLE HOUSE LOCATION TO MAKE A REPORT.

MR. BUFFINGTON STATED HE HAD APPROXIMATELY 7-9 CREDIT/DEBIT CARDS AND HIS DRIVER'S LICENSE. MR. BUFFINGTON STATED HE DID NOT KNOW THE CREDIT/DEBIT CARDS NUMBER AND WOULD CALL BACK WHEN HE FINDS THE INFORMATION.

OFFICERS OBSERVED THE SHELL CASING INSIDE THE VEHICLE AND REQUESTED FOR MR. BUFFINGTON TO RETRIEVE THE CASING. OFFICERS OBSERVED THE DAMAGE DONE TO THE CENTER CONSUL FROM THE SHOT FIRED. OFFICERS NOTIFIED A MAJOR CRIMES DETECTIVE AND MR. BUFFINGTON RESPONDED TO THE 12TH STREET STATION TO TALK TO DETECTIVES. OFFICERS DID A BROADCAST OF THE SUBJECT AND CIRCULATED THE AREA. OFFICERS STORED THE SHELL CASING AT THE SOUTHWEST SUBSTATION. OFFICERS PROVIDED MR. BUFFINGTON WITH AN INCIDENT REPORT CARD. MVR/BWC IN USE.

NARRATIVE

ON 6/15/2025 AT APPROXIMATELY 0152 HOURS, OFFICERS WERE DISPATCHED TO THE AREA OF 601 E. 9TH STREET AT MACARTHUR PARK IN REFERENCE TO A ROBBERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE VICTIM, ROBERT HIGHFILL.

ROBERT HIGHFILL SAID HE WAS WORKING AS A LYFT DRIVER WHEN THE INCIDENT TOOK PLACE NEAR THE AREA OF 612 E. ROOSEVELT ROAD AT GAS MAX. HE SAID HE PICKED UP A RIDER IN SHERWOOD, AR, AND THE DESTINATION WAS SUPPOSED TO BE BAPTIST HOSPITAL IN LITTLE ROCK, AR. THE RIDER WAS DESCRIBED AS AN UNKNOWN BLACK MALE, APPROXIMATELY 6'0" IN HEIGHT, SMALL BUILD, BEARD, BALD, AND WEARING A RED HOODED JACKET WHILE CARRYING A BLACK BACKPACK.

ROBERT HIGHFILL SAID AS THEY WERE ON I-30 WEST, THE MALE TOLD HIM TO TAKE THE ROOSEVELT ROAD EXIT. ONCE THEY WERE NEAR THE BOTTOM OF THE OFF-RAMP, THE MALE POKED HIM WITH WHAT HE BELIEVED WAS A FIREARM INTO HIS LEFT RIBCAGE. THE MALE THEN TOLD HIM TO GET OUT, THAT THE WOMAN WHO CALLED IN THE RIDE HAD "FUCKED" HIM, AND HE PROCEEDED TO PUSH HIGHFILL OUT OF THE VEHICLE.

ROBERT HIGHFILL SAID THE STOLEN VEHICLE REGISTERED TO HIM AND HIS WIFE WAS A BLACK 2015 TOYOTA CAMRY DISPLAYING AR EDUCATOR TAGS DJR3 (VIN: 4T1BF1FK0FU044308). HE SAID THE VEHICLE ALSO CONTAINED HIS PHONE AND TWO OF HIS DEBIT CARDS, ONE OF WHICH WAS HIS LYFT DEBIT CARD. HE ALSO SAID THE TRUNK CONTAINED A BLUE COBALT TOOLBOX.

ROBERT HIGHFILL WAS LATER PICKED UP BY HIS WIFE AND ADVISED HIS PHONE WAS PINGING NEAR I-30 AND I-430. OFFICERS ESCORTED THEM TO THE AREA AND HIS PHONE WAS LOCATED ON I-30 WEST NEAR 10424 INTERSTATE 30 AT FRONTIER DINER. THEY WERE UNABLE TO LOCATE HIS VEHICLE.

OFFICERS LATER BROADCASTED A BE ON THE LOOKOUT (BOLO) FOR HIS VEHICLE. COMMUNICATIONS LATER ADVISED THAT ONE OF ROBERT HIGHFILL'S DEBIT CARDS WAS USED IN BRYANT, AR, WHICH WAS THE GENERAL DIRECTION OF THE VEHICLE'S LAST KNOWN DIRECTION OF TRAVEL. OFFICERS ADVISED COMMUNICATIONS TO NOTIFY BRYANT POLICE DEPARTMENT (BPD) AND SALINE COUNTY SHERIFF'S OFFICE (SCSO). OFFICERS ALSO NOTIFIED ACIC TO ENTER THE VEHICLE INTO THE SYSTEM AS STOLEN.

AT APPROXIMATELY 0410 HOURS, OFFICERS WERE ADVISED BY COMMUNICATIONS TO CONTACT ROBERT HIGHFILL SO HE COULD PROVIDE ADDITIONAL INFORMATION. HE STATED THE FEMALE WHO INITIALLY GENERATED THE RIDE WAS COURTNEY HUNT WITH AN ADDRESS OF 11 PARKRIDGE DRIVE AND ZIP CODE OF 72120. OFFICERS WERE ABLE TO LOCATE HER IN ATLAS AND OBTAIN HER DATE OF BIRTH (8/11/1992).

ROBERT HIGHFILL SAID COURTNEY HUNT POSSIBLY RECEIVED NOTIFICATIONS THAT DUE TO THE RIDE NOT BEING COMPLETED, SHE WAS STILL BEING CHARGED AND WAS GETTING UPSET, SO SHE SENT HIM SOME MESSAGES THROUGH THE LYFT APP. WHEN HE EXPLAINED TO HUNT WHAT HAPPENED, SHE EXPLAINED WHO THE RIDER WAS. SHE SAID THE RIDER WAS HER CHILD'S FATHER, KEITH LAMAR MARSHALL WHOSE DATE OF BIRTH WAS 11/14/1986. OFFICERS WERE ABLE TO CONFIRM HIS INFORMATION THROUGH ATLAS AS WELL. HE ALSO RECEIVED PHOTOS OF MARSHALL FROM HUNT AND HIGHFILL WAS ABLE TO CONFIRM THAT MARSHALL WAS THE ONE WHO STOLE HIS VEHICLE.

ROBERT HIGHFILL PROVIDED THE PHOTOS SENT TO HIM BY COURTNEY HUNT OF KEITH MARSHALL, WHICH APPEARED TO MATCH THE FEATURES OF MARSHALL. HE ALSO PROVIDED AN AUDIO RECORDING OF A PHONE CALL BETWEEN HIM AND HUNT. THE RECORDING HAD HUNT PROVIDING MARSHALL'S INFORMATION TO HIGHFILL. SHE ALSO GAVE HIGHFILL PERMISSION TO FORWARD HER INFORMATION TO THE POLICE. SHE ALSO SAID HOW MARSHALL NEEDED HELP AND APOLOGIZED TO HIGHFILL.
