NARRATIVE

ON JUNE 14TH, 2025, AT APPROXIMATELY 0233 HOURS, OFFICERS RESPONDED TO THE MENTIONED ADDRESS FOR A SHOOTING JUST OCCURRED. UPON ARRIVAL, OFFICERS LOCATED MR. GOMEZ WHO WAS SUFFERING FROM AN APPARENT GUNSHOT WOUND TO THE HEAD. MEMS AND RESCUE RESPONDED AND MR. GOMEZ WAS PRONOUNCED DECEASED ON SCENE.

HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASED THE AREA FOR SURVEILLANCE AND WITNESSES. MR. FUENTES ALONG WITH SEVERAL WITNESSES WERE TRANSPORTED TO THE MAJOR CRIMES DIVISION. MR. FUENTES PROVIDED A POST MIRANDA STATEMENT. MR. FUENTES WAS RELEASED WITHOUT CHARGES PENDING A FILE REVIEW BY THE PULASKI COUNTY PROSECUTING ATTORNEY. THE PULASKI COUNTY CORONER???S OFFICE RESPONDED TO THE SCENE AND TOOK POSSESSION OF THE DECEDENT'S BODY FOR AN AUTOPSY. NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ONGOING.
