NARRATIVE

D. BOREING (VICTIM) FLAGGED ME DOWN AT THE INTERSECTION OF S. PINE ST. AND INTERSTATE 630 AND STATED THAT HE NEEDED TO MAKE A ROBBERY REPORT. I HAD D. BOREING RELOCATE TO A UAMS PARKING LOT LOCATED IN THE 500 BLOCK OF S. PINE ST. D. BOREING STATED THAT THE INCIDENT OCCURRED ON JUNE 15, 2025 AT APPROXIMATELY 1 PM. D. BOREING STATED THAT HE WAS IN THE PARKING LOT OF CRUISERS BOUTIQUE, LOCATED AT 2923 W. 65TH ST., SITTING INSIDE OF HIS SUV (VEHICLE 1) WHEN HE WAS APPROACHED BY AN UNKNOWN BLACK MALE. D. BOREING STATED THAT THE BLACK MALE APPROACHED THE PASSENGER SIDE OF HIS SUV AND ASKED FOR A CIGARETTE. D. BOREING STATED THAT HE AGREED TO PROVIDE THE BLACK MALE WITH A CIGARETTE. D. BOREING STATED THAT THE BLACK MALE ENTERED THE FRONT PASSENGER SEAT OF HIS SUV AND UNEXPECTEDLY BRANDISHED A BUCK STYLE KNIFE. D. BOREING STATED THAT THE UNKNOWN BLACK MALE TOOK HIS CELL PHONE AND TOLD HIM TO DRIVE TO AN UNKNOWN VALERO GAS STATION IN JACKSONVILLE, AR. D. BOREING STATED THAT THE BLACK MALE MADE HIM ENTER THE GAS STATION AND WITHDRAW 100 DOLLARS FROM AN ATM INSIDE OF THE BUSINESS. D. BOREING STATED THAT THE BLACK MALE THEN FORCED HIM TO DRIVE TO THE MCDONALDS, LOCATED AT 816 W MAIN ST IN JACKSONVILLE, AR. D. BOREING STATED THAT AFTER HE ARRIVED AT THE MCDONALDS THE BLACK MALE EXITED HIS CAR AND ENTERED THE PASSENGER SIDE OF A TRUCK AND PURCHASED UNKNOWN NARCOTICS. D. BOREING STATED THAT THE BLACK MALE RETURNED TO HIS VEHICLE AND FORCED HIM TO DRIVE TO THE BEL AIR MOTEL, LOCATED AT 6013 US 70 IN NORTH LITTLE ROCK, AR. D. BOREING STATED THAT AFTER HE ARRIVED AT THE MOTEL, THE BLACK MALE PUNCHED HIM IN THE MOUTH AND FORCED HIM TO WITHDRAW 50 DOLLARS FROM AN UNKNOWN ATM TO RENT A ROOM. AFTER RENTING THE ROOM. D. BOREING STATED THAT THE BLACK MALE FORCED HIM TO TAKE A HAND FULL OF UNKNOWN PILLS. D. BOREING STATED THAT AT SOME POINT THE BLACK MALE WENT THROUGH HIS BELONGINGS AT THE MOTEL BUT HE DID NOT TAKE ANYTHING OTHER THAN THE CELL PHONE AND REMAINING US CURRENCY. D. BOREING STATED THAT THE BLACK MALE LEFT THE AREA ON FOOT. D. BOREING STATED THAT ONCE THE BLACK MALE WAS GONE, HE ENTERED HIS VEHICLE AND DROVE AWAY. D. BOREING STATED THAT HE DID NOT FEEL WELL SO HE PULLED INTO THE PARKING LOT OF A NEARBY DOLLAR GENERAL STORE. D. BOREING STATED THAT AT APPROXIMATELY 4PM ON JUNE 15, 2025, NORTH LITTLE ROCK POLICE OFFICERS RESPONDED TO THE DOLLAR GENERAL BECAUSE EMPLOYEES CALLED THE POLICE ON HIM DUE TO HIS STRANGE BEHAVIOR. D. BOREING STATED THAT NLRPD OFFICERS SEARCHED HIS VEHICLE FOR ILLEGAL DRUGS WITH NEGATIVE RESULTS. D. BOREING STATED THAT HE WAS TRANSPORTED TO BAPTIST SPRING HILL FOR A MEDICAL EVALUATION. D. BOREING STATED THAT HE WAS ADVISED BY HOSPITAL STAFF THAT HE HAD METHAMPHETAMINE AND FENTANYL IN HIS SYSTEM. D. BOREING STATED THAT WAS HE RELEASED FROM THE HOSPITAL ON JUNE 16, 2025 AT APPROXIMATELY 3 PM. D. BOREING STATED THAT A FRIEND TOOK HIM TO GET HIS VEHICLE AT THE DOLLAR GENERAL PARKING LOT IN NORTH LITTLE ROCK. D. BOREING DESCRIBED THE SUSPECT AS A TALL, SKINNY, DARK SKINNED BLACK MALE IN HIS EARLY TO MID 30S, D. BOREING STATED THAT THE BLACK MALE WAS WEARING A BLACK AND BLUE BUTTON UP SHIRT, BLUE JEANS, AND HAD A BLACK BACK PACK. I ADVISED D. BOREING TO COLLECT ANY ADDITIONAL INFORMATION ABOUT HIS TELEPHONE AND BANKING TRANSACTIONS FOR INVESTIGATORS. BWC WAS FUNCTIONING.
