NARRATIVE

OFFICER MADE CONTACT WITH JUVENILE VICTIM WHO STATED THAT HE WAS ROBBED. JUVENILE STATED THAT THE INCIDENT OCCURRED AT 6303 HEATHER LANE (RICHLAND PARK). JUVENILE STATED THAT THE INCIDENT OCCURRED BETWEEN 1630 AND 1700 HOURS ON 06/18/2025. JUVENILE STATED THAT HE WAS WITH THE 2 JUVENILE SUSPECTS AND JUVENILE WITNESS. HE STATED THAT THEY ARE ALL FRIENDS AND WAS JUST HANGING OUT TODAY. HE STATED THAT THEY ADVISED THEY WERE GOING TO GO TO RICHLAND PARK TO PURCHASE SOME MARIJUANA. HE STATED THAT THE JUVENILE WITNESS DROVE THE VEHICLE TO THE PARK AND UPON ARRIVAL JUVENILE SUSPECT 1 GOT OUT OF THE FRONT PASSENGERS SIDE SEAT, THEN PROCEEDED TO OPEN THE PASSENGER SIDE REAR DOOR WHERE HE WAS SITTING. HE STATED THAT JUVENILE SUSPECT 1 PULLED OUT WHAT APPEARED TO BE A BLACK TAURUS SEMI-AUTOMATIC 9MM HANDGUN. HE STATED THAT JUVENILE SUSPECT 1 PLACED THE GUN TO HIS CHEST AND TOLD HIM TO GIVE HIM ALL HIS PROPERTY. JUVENILE VICTIM STATED THAT HE LAUGHED AT FIRST BECAUSE HE THOUGHT IT WAS JUST A JOKE. JUVENILE VICTIM STATED THAT JUVENILE SUSPECT 2 THEN PROCEEDED TO TAKE A RED NIKE TECH JACKET OFF OF HIM WHILE JUVENILE SUSPECT 1 CONTINUED TO HOLD HIM AT GUN POINT. HE STATED THAT JUVENILE SUSPECT 2 THEN WENT INTO HIS POCKETS AND TOOK \$5.98 FROM HIS POSSESSION. JUVENILE VICTIM STATED THAT JUVENILE SUSPECT 1 THEN TOOK THE \$5.98 AND A GRAY SPLAT-R-BALL GUN. JUVENILE VICTIM ADVISED THAT A SPLAT-R-BALL GUN SHOOTS SMALL PLASTIC ORBS AND IS A TOY GUN. HE STATED THAT SUSPECT 2 KEPT THE RED NIKE TECH JACKET THAT HE TOOK OFF OF HIM. HE STATED THAT WHEN THE ROBBERY WAS OCCURRING JUVENILE WITNESS 1 TOLD JUVENILE SUSPECTS 1 AND 2 TO CHILL OUT WHEN THE GUN WAS PULLED. HE STATED THAT AFTER THE INCIDENT JUVENILE WITNESS 1 DROVE HIM HOME WITHOUT FURTHER INCIDENT. JUVENILE VICTIMS FATHER, MR. KAWARD JOLLY WAS PROVIDED THE INCIDENT NUMBER. CONTACT WAS MADE WITH SGT.
