NARRATIVE

OFFICERS WERE CALLED TO THE ST VINCENTS HOSPITAL IN SHERWOOD FOR A SHOOTING VITIM. OFFICERS MADE CONTACT WITH SHERWOOD PD AND AGWUH IN THE ER. AGWUH ADVISED HE ARRIVED IN LITTLE ROCK BY TRAIN AROUND 2315 HOURS ON 6-18-25. AGWUH SAID HE HAD NO EATEN ALL DAY AND HAD NO MONEY OR PHONE TO EITHER, SO HE BEGAN TO WALK. AGWUH WAS NOT SURE WHICH WAY HE HAD GONE OR WHERE. AGWUH STATED HE WAS WALKING DOWN THE STREET WHEN HE HEARD TO LOUD"POP" NOISES AND SUDDENLY FELT PAIN IN HIS LEFT. HE FELL TOT HE GROUND AND REALIZED HE HAD BEEN SHOT. AGWUH SAID HE YELLED FOR HELP FOR ABOUT 5-10 MINUTES WHEN AN UNKNOWN B/M IN A BLACK HYUNDAI SEDAN (2012-2020 MODEL) PULLED UP AND HELPED HIM INTO THE CAR. THE B/M THEN TRANSPORTED AGWUH TO ST VINCENTS IN SHERWOOD. SECURITY FOOTAGE ONLY SHOWS AGWUH WALKING INTO THE PARKING LOT FROM WILDWOOD AVE. AGWUH DID SAY THE DRIVER DROPPED HIM OFF AT THE EDGE OF THE PARKING LOT. OFFICERS CIRCULATED THE AREA OF THE TRAIN STATION BUT COULD NOT LOCATE A CRIME SCENE OR WITNESSES. OFFICERS SPOKE TO THE NIGHT CLERK AT THE STATION, BUT HE DID NOT RECALL AGWUH OR HEAR ANY SHOTS FIRED. AGWUH RECEIVED A SINGLE THROUGH AND THROUGH SHOT TO HIS RIGHT LEG. MAJOR CRIMES WAS NOTIFIED.
