NARRATIVE

ON THIS DATE, OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A BATTERY. OFFICERS MADE CONTACT WITH ENARYA CLINTON WHO STATED SHE WAS IN AN ARGUMENT WITH HER EX-BOYFRIEND, AND HE TOOK HER BAG. CLINTON STATED HER EX-BOYFRIEND SHYKWAN FRANKLIN WAS WAITING ON HER AT HER APARTMENT WHEN SHE ARRIVED. CLINTON STATED FRANKLIN ADVISED HER TO COME TALK TO HIM WHICH SHE DID. CLINTON STATED SHE RECEIVED TEXT MESSAGES AND FRANKLIN ADVISED HER TO LET HIM SEE HER PHONE. CLINTON STATED SHE TOLD HIM NO AND FRANKLIN REACHED FOR HER PHONE TRYING TO RETRIEVE IT FROM HER, CLINTON STATED SHE HELD HER PHONE TIGHT AND FRANKLIN ASKED WHAT SHE HAD IN HER BAG. CLINTON STATED FRANKLIN BEGAN TO TAKE THE BAG FROM HER. CLINTON STATED DURING THE FIGHT OVER THE BAG THE TWO WENT TO THE GROUND AND FRANKLIN TOOK THE BAG AND ONE OF HER PINK CROCS AND LEFT THE LOCATION. CLINTON STATED SHE RAN TO HER APARTMENT AND NOTIFIED HER MOTHER MARCONIA CLINTON. CLINTON STATED THIS HAPPENED AT APPROXIMATELY 0000 HOURS. MARCONIA ADVISED OFFICERS FRANKLIN GAVE CLINTON A SEXUALLY TRANSMITTED DISEASE KNOWINGLY BUT HAVE NOT RECEIVED THE TEST RESULTS BACK. MARCONIA STATED THERE ARE CAMERAS OUTSIDE OF THE APARTMENT COMPLEX. CLINTON STATED SHE HAD A PHONE CHARGER, UGG'S, CLOTHES, AND HAIR PRODUCTS IN THE BAG. CLINTON ADVISED THE BAG WAS A BLUE "PINK" BRAND BEACH BAG WITH WHITE POLKA DOTS AND FLOWERS ON THE BAG. CLINTON STATED THE ITEMS FRANKLIN TOOK WERE WORTH APPROXIMATELY 400 DOLLARS. CLINTON STATED FRANKLIN DRIVES AN OLDER BLUE FORD EXPEDITION AND HAS BEEN TAKING HER TO A HOUSE OFF 19TH BY FAIR PARK. OFFICERS OBSERVED INJURY TO CLINTONS LEFT KNEE, LEFT FOREARM, AND RIGHT HAND. OFFICERS GAVE A BROADCAST OF THE INCIDENT AND GAVE CLINTON A LAURA'S AND LETHALITY ASSESSMENT. BWC IN USE.

NARRATIVE

WHILE ON PATROL, COMMUNICATIONS ADVISED THAT THEY RECEIVED A SHOT SPOTTER ACTIVATION OF THREE ROUNDS AT 2216 ELM STREET. AS OFFICERS BEGAN TO RESPOND TO THE LOCATION, COMMUNICATIONS ADVISED THEY RECEIVED A SECOND SHOT SPOTTER ACTIVATION FOR FIVE ROUNDS AT THE SAME LOCATION. AN ADDITIONAL CALLER, WHICH WAS SPANISH SPEAKING, ADVISED THAT A BULLET HAD GONE THROUGH THEIR WINDOW AT 4024 W 22ND STREET.

ONCE ON SCENE, OFFICERS BEGAN TO CANVAS THE AREA FOR POSSIBLE SHELL CASINGS AND DISCOVERED SEVEN SILVER COLORED 9MM SPENT CASINGS AND ONE SILVER COLORED 9MM LIVE AMMUNITION ROUND WHICH WERE LOCATED ON THE GROUND THE BETWEEN 4100-4115 BLOCK OF 22ND STREET.

CONTACT WAS THEN MADE WITH THE SPANISH SPEAKING COMPLAINANT, CONCEPCION ALVAREZ (VIC 1) WHO ADVISED THAT SHE WAS OUTSIDE HER RESIDENCE WHEN SHE OBSERVED AN UNKNOWN BLACK MALE WALKING NEAR 22ND AND ELM STREET WHO BEGAN SHOOTING. MS. ALVAREZ ADVISED SHE DID NOT KNOW IF THE SUSPECT WAS SHOOTING TOWARD HER DIRECTION BUT IMMEDIATELY RAN BACK INSIDE HER RESIDENCE WHEN SHE HEARD THE GUNSHOTS AND SHELTERED ALL FIVE CHILDREN SHE HAD BEEN BABYSITTING WHO WERE INSIDE. MS. ALVAREZ DESCRIBED THE SUSPECT AS A BLACK MALE AROUND 18 YEARS OLD WEARING ALL BLACK LAST SEEN HEADING NORTHBOUND ON ELM STREET.

A BROADCAST WAS MADE IN REGARD TO THE INCIDENT AND SUSPECTS POSSIBLY INVOLVED.

OFFICERS WALKED THROUGH MS. ALVAREZ RESIDENCE AND OBSERVED TWO STRUCK WINDOWS ON THE EAST SIDE OF THE RESIDENCE ALONG WITH ANOTHER BULLET STRIKE ON THE FRONT OF THE RESIDENCE ON THE SOUTH SIDE. WHILE CANVASING THE INSIDE THE RESIDENCE, A BULLET FRAGMENT WAS LOCATED IN THE SOUTH SIDE BEDROOM WHICH WAS PHOTOGRAPHED AND DOCUMENTED.

OFFICERS THEN BEGAN TO SPEAK WITH NEARBY NEIGHBORS IN THE AREA WHO ADVISED THAT THEY OBSERVED A BLACK MALE SUBJECT RUN TO THE RESIDENCE LOCATED AT 4115 W 22ND STREET AFTER THE SHOTS WERE FIRED. OFFICERS ATTEMPTED TO MAKE CONTACT WITH RESIDENCE AT THE LISTED LOCATION BUT OBTAINED NEGATIVE RESULTS. AS OFFICERS WERE LEAVING THE RESIDENCE, A BLACK CELL PHONE WAS LOCATED IN THE FRONT LAWN AREA NEAR ONE OF THE SPENT CASINGS AND WAS DOCUMENTED.

DOWNTOWN SUPERVISOR, SGT. BUTLER, WAS ADVISED OF THE INCIDENT AND MAJOR CRIME DETECTIVES WERE NOTIFIED.

MAJOR CRIME DETECTIVES RESPONDED ON SCENE AND CONDUCTED THEIR PRELIMINARY INVESTIGATION. THE CELL PHONE WAS COLLECTED BY MAJOR CRIME DETECTIVES. THE LIVE AMMUNITION ROUND, SPENT SHELL CASINGS AND BULLET FRAGMENT WERE ALSO COLLECTED AND STORED AT THE 12TH STREET PROPERTY ROOM AS EVIDENCE. NO OTHER ACTION WAS TAKEN AT THIS TIME. MVR AND BWC IN USE.

NARRATIVE

OFFICERS RESPONDED TO 3 EAGLE HILL DRIVE FOR REPORT OF A ROBBERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH HUSSEINI. HUSSEINI ADVISED HE AGREED TO MEET WITH A SUBJECT VIA FACEBOOK MESSENGER TO BUY A PLAY-STATION FIVE. HUSSEINI AGREED TO MEET THE SUBJECTS AT 7 BOGEY LANE.

HUSSEINI ADVISED WHEN HE ARRIVED HE WAS APPROACHED BY THREE BLACK MALES WHO ADVISED THEY HAD THE PLAY STATION FOR SALE. THE MALES WERE ALL REPORTEDLY IN THEIR 20'S BUT HUSSEINI COULD ONLY REMEMBER ONE WAS WEARING A BROWN HOODIE AND A BLACK DURAG. NONE OF THE MEN HAD THEIR FACES COVERED.

HUSSEINI ADVISED THE BLACK MALE WEARING A BROWN HOODIE SHOWED HIM THE PLAY STATION WHICH WAS IN A BACK PACK. HUSSEINI STATED THE PLAYSTATION HAD STICKERS ALL OVER IT AND HE DID NOT WANT IT.

WHEN HUSSEINI EXPRESSED THIS THE SUSPECT ASKED HIM IF HE HAD THE AGREED AMOUNT OF MONEY WHICH WAS \$300.
