NARRATIVE

OFFICERS RESPONDED TO THE AREA OF W. MARKHAM AND UNIVERSITY AVE FOR A REPORTED KIDNAPPING IN PROGRESS. OFFICERS WERE ADVISED THAT A MALE ATTACKED A FEMALE, CRYSTAL GATEWOOD, AT HER PLACE OF WORK, FORCED HER INTO A CAR, AND WAS DRIVING AROUND WITH HER IN THE CAR. OFFICERS WERE RECEIVING THIS INFORMATION FROM THE FEMALE'S BOYFRIEND, DEWAYNE AUSTIN, WHO WAS ON THE PHONE WITH GATEWOOD WHEN THIS HAPPENED. AUSTIN WAS ALSO PROVIDING THE GPS LOCATION OF GATEWOOD DUE TO THEM SHARING THEIR LOCATION WITH ONE ANOTHER. OFFICERS WERE ADVISED GATEWOOD AND THE MALE WERE IN A BURGUNDY TOYOTA CAMRY AND WERE IN THE SOUTH PARKING LOT OF PARK PLAZA MALL.

OFFICERS LOCATED THE VEHICLE IN THE ATM DRIVE THRU OF BANK OF AMERICA, 6320 W MARKHAM; WHICH IS IN THE SOUTH PARKING LOT OF PARK PLAZA MALL. OFFICERS FOUND A BLACK MALE, LATER IDENTIFIED AS RONNIE WILLIAMS, IN THE DRIVER'S SEAT AND GATEWOOD IN THE PASSENGER'S SEAT, WILLIAMS WAS TAKEN INTO CUSTODY AND PLACED INTO A PATROL CAR. GATEWOOD WAS MOVED AWAY FROM WILLIAMS AND ASKED ABOUT WHAT HAPPEN. GATEWOOD STATED SHE WAS TALKING WITH AUSTIN ON THE PHONE WHILE WALKING OUT TO HER CAR AFTER GETTING OFF WORK WHEN WILLIAMS APPROACHED HER IN THE PARKING LOT. GATEWOOD STATED SHE REMEMBERED TELLING AUSTIN, "WHAT THE FUCK HE DOING HERE? HE'S STALKING ME." GATEWOOD ADVISED WILLIAMS STRUCK HER IN THE FACE THREE TIMES WITH AN OPEN HAND, TOOK HER KEYS, AND TOLD HER "GET IN THE CAR OR I'LL BEAT YOUR ASS BLOODY." GATEWOOD STATED SHE GOT IN THE CAR FOR FEAR HE WOULD CONTINUE TO ATTACK HER. GATEWOOD ADVISED THEY DROVE AROUND FOR A MINUTE AND WHILE THEY WERE DRIVING AUSTIN WAS ON THE PHONE, BUT WILLIAMS KEPT HANGING THE PHONE UP ON AUSTIN. GATEWOOD STATED AT ONE POINT WILLIAMS TOOK THE PHONE AND TOLD AUSTIN, "I'M BRINGING YOUR BITCH BACK, JUST TELL ME WHERE YOU LIVE." GATEWOOD ADVISED SHE COULDN'T HEAR WHAT AUSTIN SAID, BUT WILLIAMS THEN SAID. "I'LL SHOOT YOU. TELL ME WHERE YOU LIVE OR I'LL BEAT IT OUT OF HER." GATEWOOD STATED THEY CONTINUED TO DRIVE AROUND UNTIL SHE OFFERED TO GIVE HIM \$400 TO LET HER GO. GATEWOOD ADVISED WILLIAMS AGREED AND THAT IS WHY THEY WERE AT THE ATM WHEN OFFICERS ARRIVED. GATEWOOD STATED HER FACE WAS HURTING AND HER LIPS FELT LIKE THEY WERE SWOLLEN. GATEWOOD ADVISED WILLIAMS AND HERE WERE IN A SEXUAL RELATIONSHIP FOR OVER A MONTH EARLIER THIS YEAR, BUT SHE HAD CALLED IT OFF AROUND THE FIRST OF MAY. ACIC SHOWED WILLIAMS TO HAVE SUSPENDED DRIVER'S LICENSE AS WELL.

OFFICERS TRANSPORTED WILLIAMS TO THE 12TH STREET SUBSTATION AND HAD GATEWOOD AND AUSTIN MEET THEM THERE AS WELL TO SPEAK WITH DETECTIVES. OFFICERS SPOKE WITH AUSTIN AS WELL WHO STATED ONE OF THE TIMES HE WAS ON THE PHONE WITH GATEWOOD, WILLIAMS TOOK THE PHONE AND TOLD HIM HE WAS GOING TO SHOOT HIM. WILLIAMS WAS ADVISED OF HIS MIRANDA RIGHTS BY DETECTIVES AND DECLINED TO MAKE A STATEMENT.

WILLIAMS WAS CHARGED WITH KIDNAPPING, ROBBERY, UNAUTHORIZED USE OF ANOTHER PERSON'S PROPERTY TO FACILITATE A CRIME, THEFT OF PROPERTY, TERRORISTIC THREATENING 1ST DEGREE, TERRORISTIC THREATENING 2ND DEGREE, DOMESTIC BATTERY 3RD DEGREE, AND DRIVING ON SUSPENDED DRIVER'S LICENSE. WILLIAMS WAS TRANSPORTED TO PCRJ FOR PROCESSING.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A BATTERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MS. DOZIER, WHO ADVISED MR. FOSTER JUST TOOK HER RIFLE AND 1300 DOLLARS IN CASH AND HAD JUST RUN SOUTH FROM THE LISTED LOCATION. OFFICERS CIRCULATED FOR MR. FOSTER WITH NEGATIVE RESULTS. OFFICERS CIRCLED BACK AND SPOKE WITH MS. DOZIER.

MS. DOZIER. SHE ADVISED SHE WAS JUST AT HOME WHEN MR. FOSTER CAME OVER, UPSET DUE TO TODAY BEING THE DAY HER MOM PASSED AWAY SOME YEARS AGO. MS. DOZIER STATED SHE DIDN'T THINK ANYTHING OF IT AND LET HIM IN DUE TO BOTH BEING FRIENDS. MS. DOZIER ADVISED MR. FOSTER STARTED TO GET ANGRY AND WENT INTO HER CLOSET AND STARTED TO MAKE A MESS. WHILE MR. FOSTER WAS IN THE CLOSET, THE RIFLE FELL. MR. FOSTER STATED, "THIS IS MINE NOW," AND THAT'S WHEN MS. DOZIER GRABBED THE RIFLE TO GET IT BACK, AND MR. FOSTER BIT MS. DOZIER'S BREAST AREA. OFFICERS OBSERVED BITE MARKS ON THE CHEST AREA OF MS. DOZIER.

MS. DOZIER THEN ADVISED MR. FOSTER SNATCHED THE RIFLE FROM HER HANDS, CAUSING THE RIFLE TO HIT HER IN THE FACE. OFFICERS ALSO OBSERVED REDNESS AND A BLOODY NOSE ON MS. DOZIER. MS. DOZIER THEN STATED SHE FELL ON THE GROUND AND MR. FOSTER GOT ON TOP OF HER AND STARTED TO CHOKE HER. MS. DOZIER ADVISED SHE FELT LIKE SHE WAS GOING TO DIE DUE TO HER NOT BEING ABLE TO BREATHE. OFFICERS DID SEE REDNESS AND SCRATCHES ON MS. DOZIER'S NECK. MS. DOZIER ADVISED MR. FOSTER LEFT THE SCENE ON FOOT. MS. DOZIER ADVISED SHE DID NOT NEED MEDICAL ATTENTION.
