## **NARRATIVE**

OFFICERS MADE CONTACT WITH MR. BRANCH AT 9506 DARTMOUTH IN REFERENCE TO BEING ROBBED AT GUN POINT AT 9 BOGEY LANE. MR. BRANCH ADVISED HE WAS SELLING A PAIR OF WHITE JORDAN 3 SHOES ON FACEBOOK MARKETPLACE AND AN UNKNOWN INDIVIDUAL, KNOWN AS JAYSHAWN BULTER, NOTIFIED HIM ON MESSENGER SAYING HE WANTED TO BUY THE SHOES BUT DID NOT HAVE ANY TRANSPORTATION. MR. BRANCH ADVISED HE WENT TO 9 BOGEY LANE AND MET WITH THE UNKNOWN MALE WHO STARTED COUNTING OUT CASH BUT THEN TOLD HIM HE WOULD GIVE HIM \$40.00 AND THEN VIMO THE OTHER \$60.00 TO HIM AND ASKED FOR HIS VIMO ACCOUNT. MR. BRANCH THEN ADVISED THE UNKNOWN MALE KEPT MESSAGING WITH SOMEONE AND AFTER APPROXIMATELY 15 MINUTES, PULLED AN UNKNOWN CALIBER BLACK HANDGUN (AR STYLE) AND POINTED THE GUN AT HIM AND SAID, "DRIVE AWAY." MR. BRANCH LEFT THE AREA BACK TO ALEXANDER AND CALLED THE POLICE BUT WAS TRANSFERRED TO TRU. MR. BRANCH WAS ADVISED HE NEEDED TO RETURN BACK TO LITTLE ROCK TO MAKE THE REPORT. MR. ## **NARRATIVE**

FREEBY STATED WHEN HE MET UP JAYSHAWN THERE WAS ANOTHER BLACK MALE WITH A BACKPACK WITH HIM. MR. FREEBY STATED JAYSHAWN WAS COUNTING THE MONEY, THE UNKNOWN BLACK MALE PULLED OUT A BLACK AR PISTOL FROM HIS WAISTBAND AND TOLD HIM THAT IT WAS A ROBBERY. MR. FREEBY ADVISED PUTTING THE GAMING CONSOLE IN THE BACKPACK AND OBSERVED BOTH SUBJECTS RUN TO THE BACK OF THE APARTMENTS.
