### **NARRATIVE**

ON 07/06/2025 OFFICERS RESPONDED TO THE LISTED LOCATION FOR SHOOTING CALL. UPON ARRIVAL, OFFICERS LOCATED VIC#1 LYING ON THE GROUND BEHIND THE LISTED APARTMENT BUILDING.

OFFICERS SECURED THE SCENE AND PROVIDED AID TO VIC#1. VIC#1 PROVIDED MINIMAL INFORMATION TO OFFICERS ABOUT THE ALTERCATION THAT HAD TRANSPIRED. OFFICERS MADE A BRIEF BROADCAST CONTAINING SUSPECT INFORMATION. ENGINE 16 WITH THE LRFD RESPONDED TO THE SCENE TO TREAT VIC#1. MEMS TRANSPORTED VIC#1 TO ARKANSAS CHILDREN'S HOSPITAL.

OFFICERS OBSERVED SEVERAL SHELL CASES LOCATED IN THE DRIVEWAY AND REAR PARKING AREA. OFFICERS OBSERVED A BLOOD TRAIL STARTING BEHIND THE LISTED VEHICLE THAT WAS LOCATED IN THE DRIVEWAY. ### **NARRATIVE**

### NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A SHOTS FIRED CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH VICT#1(TABRON). TABRON STATED HER DAUGHTER VICT#2(T. ELLIS) CONTACTED HER VIA CELL PHONE ADVISING MULTIPLE SHOTS WERE FIRED, AND THE LISTED LOCATION WAS STRUCK SEVERAL TIMES. TABRON STATED VEH#1, AND VEH#2 WERE ALSO STRUCK SEVERAL TIMES BY GUNFIRE. OFFICERS OBSERVED SEVERAL DIFFERENT SHELL CASINGS IN FRONT OF THIS LOCATION. OFFICERS OBSERVED THIS LOCATION WAS STRUCK SEVERAL TIMES APPROXIMATELY 10-12. TABRON STATED THIS LOCATION WAS STRUCK BY GUNFIRE LAST SUMMER THEREFORE THERE WERE OLD BULLET HOLES PRESENT IN, AND OUTSIDE OF THE RESIDENCE. T. ELLIS, THE OWNER OF THIS LOCATION WAS NOT ON SCENE UPON OFFICERS ARRIVAL. TABRON STATED T. ELLIS LEFT THE AREA WALKING TOWARD A NEARBY ALLY. OFFICERS ENTERED THIS LOCATION TO ENSURE THERE WERE NOT ANY VICTIMS NEEDING MEDICAL ATTENTION WITHIN THE RESIDENCE. OFFICERS OBSERVED JUV#1, AND JUV#2 ASLEEP INSIDE, BOTH WERE NOT STRUCK. VICT#3(S. ELLIS) WAS ALSO INSIDE AND WAS NOT STRUCK. DUE TO A SEPARATE INCIDENT (2025-083073), TABRON AND S. ELLIS WERE ADVISED TO GATHER JUV#1, AND JUV#2 AND LEAVE THE RESIDENCE. SHORTLY AFTER THE RESIDENCE WAS CLEARED, T. ELLIS RETURNED ON SCENE ADVISING HER RESIDENCE WAS SHOT UP. OFFICERS ASKED T. ELLIS IF SHE KNEW A POSSIBLE SUSPECT; T. ### NARRATIVE

ON JULY 4, 2025, OFFICERS WERE DISPATCHED TO THE LIQUOR EXCHANGE, DUE TO A BATTERY IN PROGRESS CALL. COMMUNICATIONS ADVISED TWO HISPANIC MALES WERE FIGHTING AND ONE WAS STRIKING THE OTHER WITH A BAT. UPON ARRIVAL, THE VICTIM WAS LOCATED ON THE EAST SIDE OF THE LIQUOR STORE. HE WAS LATER IDENTIFIED AS MR. TORRES (VICTIM ONE). MR. TORRES HAD BLOOD COMING DOWN HIS FACE AND A LARGE LACERATION ON HIS HEAD. HE COULD NOT SPEAK AND APPEARED TO BE INTOXICATED. MR. TORRES WAS ASKED MULTIPLE TIMES WHAT HAPPENED BUT DID NOT ANSWER ANY QUESTIONS AND JUST KEPT HIS EYES CLOSED. OFFICERS LOCATED THE SUSPECT MATCHING THE DESCRIPTION GIVEN BY THE 911 CALLER NEAR BASELINE ROAD AND GEYER SPRINGS ROAD. HE WAS LATER IDENTIFIED AS MR. WAGNER (SUSPECT TWO). MR. WAGNER WAS DETAINED AND PLACED IN HANDCUFFS (DOUBLE LOCKED AND CHECKED FOR TIGHTNESS) FOR FURTHER INVESTIGATION. HE STATED HE WAS COMING FROM THE RALLY'S AND DIDN'T "LIKE TO FIGHT." HE HAD BLOOD ON HIS SHIRT AND STATED THE BLOOD WAS FROM "PICKING HIS SCABS."

AN OFFICER LOCATED THE BAT AND TOOK PHOTOS OF IT AND COLLECTED IT AS EVIDENCE. OFFICERS MADE CONTACT WITH MS. LUCAS (CONTACT ONE) WHO STATED SHE WITNESSED THE FIGHT. SHE STATED BOTH SUBJECTS WERE IN AN ARGUMENT AND THEN MR. WAGNER STRUCK MR. TORRES MULTIPLE TIMES ON THE HEAD WITH A BAT. SHE STATED MR. TORRES FELL BACK AND MR. WAGNER KEPT STRIKING HIM ON THE HEAD WITH A BAT WHILE MR. TORRES WAS ON THE GROUND. SHE STATED SHE SCREAMED AT HIM BECAUSE MR. WAGNER WAS GOING TO STRIKE ONE MORE TIME. SHE SAID HE STOPPED AND THEN LEFT.

OFFICERS MADE CONTACT WITH THE LIQUOR STORE CLERK, MR. CHARTON (CONTACT TWO). MR. CHARTON PROVIDED A WRITTEN STATEMENT. HE STATED THE TWO MALES WERE HANGING OUT OUTSIDE OF THE LIQUOR STORE ALL DAY. HE STATED THEY WERE SHARING A BOTTLE OR LIQUOR AND BEGAN TO ARGUE. MR. CHARTON STATED MR. WAGNER STRUCK MR. TORRES ON THE HEAD MULTIPLE TIMES. MR. CHARTON STATED MR. WAGNER ALSO STRUCK HIM WITH HIS FIST AND KICKED HIM.

MR. TORRES WAS TRANSPORTED TO A LOCAL HOSPITAL FOR FURTHER MEDICAL ASSISTANCE. HIS CLOTHING AND SHOES WERE TAKEN AS EVIDENCE. MR. WAGNER WAS TRANSPORTED TO THE MAJOR CRIMES DETECTIVE'S OFFICE. HE WAS THEN TRANSPORTED TO PCRJ WHERE HE WAS BOOKED IN AND CHARGED WITH BATTERY 1ST. BWC WAS IN USE.

### **NARRATIVE**

ON JULY 6TH, 2025, AT 0317 HOURS, OFFICERS RESPONDED CODE-3 TO A SHOOTING JUST OCCURED AT 2810 CUMBERLAND STREET, APARTMENT C. A FEMALE HAD BEEN SHOT IN THE ARM AND BACK.

OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE VICTIM, CANDAYCE TABRON. MS. TABRON HAD BEEN SHOT IN THE LEFT ARM AND THE LEFT SHOULDER BLADE AREA ON HER BACK. SHE WAS NOT BLEEDING EXCESSIVELY AND NO MEDICAL WAS PROVIDED BY OFFICERS. MEMS RESPONDED AND TOOK MS. TABRON TO UAMS FOR TREATMENT. SHE SUFFERED NON-LIFE-THREATENING INJURIES.

THE APARTMENT HAD BEEN STRUCK BY GUNFIRE. MS. TABRON TOLD OFFICERS SHE WAS ASLEEP AND HAD BEEN STRUCK. THERE WERE FOUR JUVENILES INSIDE OF THE RESIDENCE AT THE TIME OF THE INCIDENT. THEIR INFORMATION IS DOCUMENTED AS VICTIM'S IN THE REPORT.

OFFICERS SECURED THE CRIMESCENE. EVIDENCE WAS LOCATED INSIDE OF THE CRIME SCENE ALONG WITH A VEHICLE THAT HAD BEEN STRUCK BY THE GUNFIRE. THE OWNER OF THE VEHICLE COULD NOT BE CONTACTED DUE TO THE TEMPORARY TAG NOT RETURNING ANY OWNERSHIP INFORMATION. SERGEANT J. SIMS RESPONDED. DETECTIVE M. GOAD RESPONDED TO THE SCENE AND ASSUMED THE INVESTIGATION. CRIME SCENE ALSO RESPONDED.
