NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A DISTURBANCE CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. VUE HER (VICTIM 1) WHO STATED HIS PHONE (PROPERTY 1) AND IDENTIFICATION CARDS (PROPERTY 2) WERE TAKEN AFTER BEING ASSAULTED.

MR. HER STATED A UNKNOWN WHITE FEMALE LATER IDENTIFIED AS MS. JENNIFER GARNETT (SUSPECT 1) HAD TAKEN HIS PROPERTY AND DAMAGED THE WINDSHIELD (PROPERTY 3) TO HIS 2021 TOYOTA TACOMA (VEHICLE 1). MR. HER ADVISED HE WAS LOOKING FOR "JACKIE" AT THE LISTED LOCATION AND MS. GARNETT APPROACHED HIM TELLING HIM SHE WAS AT ANOTHER HOTEL.

MR. HER STATED MS. GARNETT GOT IN HIS VEHICLE AND TOLD HIM SHE WOULD LEAD HIM TO "JACKIE" IN EXCHANGE FOR MONEY. MR. HER STATED HE TOLD MS. GARNETT HE DID NOT HAVE ANY MONEY ON HIM AND SHE ASSAULTED HIM AND TOOK HIS PROPERTY AND DAMAGED HIS WINDSHIELD. MR. HER HAD MINOR INJURIES ON HIS FACE AND HE REFUSED MEDICAL ATTENTION.

MR. HER ADVISED MS. GARNETT LEFT ON FOOT TOWARD MABELVALE PIKE WITH A BACKPACK ON. OFFICERS CIRCULATED THE NEARBY AREA AND LOCATED MS. GARNETT ON MABELVALE PIKE WALKING SOUTHBOUND. MS. GARNETT STATED SHE JUST CAME FROM CHICOT ROAD AND WAS GOING TO HER SISTER'S HOUSE. OFFICERS ASKED MS. GARNETT IF SHE HAD BEEN AT THE LISTED LOCATION EARLIER AND SHE STATED NO.

OFFICERS OBSERVED THE BACKPACK ON MS. GARNETT AND ASKED HER IF SHE WOULD OPEN IT FOR US AND SHE DID. OFFICERS OBSERVED MULTIPLE IDENTIFICATION CARDS WITH MR. HER'S NAME. OFFICERS DETAINED MS. GARNETT AND RETURNED HER BACK TO THE LISTED LOCATION.

OFFICERS LOCATED MR. HER'S PHONE ON MS. GARNETT'S BACK LEFT POCKET. MR. HER ADVISED IDENTIFIED THE PHONE AS HIS DUE TO HAVING DAMAGE ON IT. OFFICERS NOTIFIED A SOUTHWEST PATROL SERGEANT AND MAJOR CRIMES DETECTIVES DUE TO THE NATURE OF THE INCIDENT.

AS OFFICERS WERE SPEAKING TO MAJOR CRIMES DETECTIVES, MR. HER STATED HE DID NOT WANT TO PROCEED WITH PRESSING CHARGES AGAINST MS. GARNETT AND HE ONLY WANTED HIS PROPERTY BACK. OFFICERS ASKED MR. HER IF HE WAS SURE HE DID NOT WANT TO PROCEED AND HE WAS CERTAIN HE DID NOT WANT TO GO THROUGH THE PROCESS.

OFFICERS NOTIFIED MAJOR CRIMES DETECTIVES OF MR. HER'S DECISION. OFFICERS PROVIDED A INCIDENT REPORT CARD TO MR. HER AND HE LEFT THE SCENE. UPON FURTHER INVESTIGATION IT APPEARED MS. GARNETT HAD AN ACTIVE WARRANT OUT OF LITTLE ROCK TRAFFIC (WARRANT# LR-25-1573) FOR FAILURE TO APPEAR.

MS. GARNETT ALSO HAD AN ACTIVE WARRANT OUT OF PULASKI COUNTY (WARRANT# 184242) FOR PROBATION VIOLATION. OFFICERS TRANSPORTED MS. GARNETT TO PULASKI COUNTY REGIONAL JAIL AND CHARGED WITH THE WARRANT ARRESTS. OFFICERS STORED MS. GARNETT'S U.S POLO BACKPACK (PROPERTY 4) AT THE SOUTHWEST PROPERTY ROOM DUE TO THE JAIL NOT TAKING IT. MVR AND BWC IN USE.

NARRATIVE

AT APPROXIMATELY 1911 HOURS, OFFICERS WERE DISPATCHED TO 2002 S. FILLMORE ST. FOR AN ASSIST MEDICAL CALL.

WHILE ON SCENE, AT APPROXIMATELY 1943 HOURS, OFFICERS HEARD MULTIPLE GUNSHOTS COMING FROM THE AREA OF S. FILLMORE ST. AND W. CHARLES BUSSEY AVE. THERE WAS ALSO A SHOT SPOTTER ACTIVATION FOR 25 ROUNDS AT 1908 S. FILLMORE ST. OFFICERS RAN TOWARD THE INTERSECTION AND OBSERVED A MAROON CHEVROLET SILVERADO IN THE DRIVEWAY OF 1908 S. FILLMORE ST. AS SOON AS THE DRIVER OF THE TRUCK SAW OFFICERS, HE STARTED TO LEAVE AND A BLACK MALE WAS OBSERVED JUMPING INTO THE PASSENGER SEAT WHILE DROPPING HIS PHONE. THE TRUCK THEN SPED OFF GOING NORTH ON S. FILLMORE ST.

OFFICERS RAN BACK TO THEIR PATROL VEHICLES AND PULLED UP AT THE RESIDENCE OF 1908 S. FILLMORE ST. OFFICERS DETAINED MR. KRISTOPHER EDWARD, WHO CAME WALKING FROM THE NORTH SIDE OF THE HOUSE. MR. MICHAEL COLEY AND MR. AMAIR WILLIAMS WERE ALSO DETAINED WHEN THEY EXITED THE HOUSE. JUVENILE 1 AND JUVENILE 2 WERE ALSO INSIDE OF THE HOUSE AT THE TIME OF THE INCIDENT. OFFICERS CLEARED THE RESIDENCE WITH NEGATIVE RESULTS. THE JUVENILES' FATHER, MR. MALIK MCDANIEL, ARRIVED ON SCENE AND STOOD BY WITH THE JUVENILES.

OFFICERS ESTABLISHED A CRIME SCENE AS SUPERVISORS ARRIVED AND TOOK CHARGE OF THE INVESTIGATION. DURING THE INVESTIGATION, OFFICERS LEARNED THAT MULTIPLE HOUSES HAD BEEN STRUCK BY GUNFIRE. 1921 S. MR. LARSON ADVISED HE JUST KNEW HIS NEIGHBOR'S NAME TO BE "SARA" AT 2001 S. FILLMORE ST. A BLACK 2008 CHEVROLET SILVERADO WAS IN THE YARD OF 1908 S. FILLMORE ST. IT TOO WAS STRUCK BY GUNFIRE. BUT THE REGISTERED OWNER, MS. EVELYN FISHER, WAS NOT ON SCENE. MULTIPLE SHELL CASINGS AND BULLET FRAGMENTS WERE LOCATED IN THE AREA. MAJOR CRIMES DETECTIVES AND CRIME SCENE UNITS ARRIVED AND PROCESSED THE SCENE. MR. EDWARD AND MR. WILLIAMS WERE RELEASED WITHOUT CHARGES. MR. COLEY WAS FOUND TO HAVE TWO ACTIVE FELONY THEFT OF PROPERTY WARRANTS. HE WAS TRANSPORTED TO PCRJ AND SERVED WITH BOTH WARRANTS, SEE INCIDENT# 2025-084756. THE INVESTIGATION IS STILL ONGOING. BWC'S WERE ACTIVATED.
