NARRATIVE

ON 07/10/2025 AT APPROXIMATELY 1933 HOURS, OFFICERS RESPONDED TO 925 FAIR PARK BLVD FOR A BATTERY REPORT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH TAMARA SIMS.

SIMS ADVISED SHE WAS SITTING IN THE PASSENGER SEAT OF A FRIEND'S CAR WITH THE WINDOWS DOWN AT PICPAC LIQUOR, 4407 W 12TH ST. SIMS ADVISED HER EX-BOYFRIEND, LESLIE ADAMS, SAW HER AND PULLED INTO THE PARKING LOT OF PICPAC, BLOCKED HER FRIEND'S CAR IN AND GOT OUT TO CONFRONT SIMS. SIMS ADVISED ADAMS WENT TO HER WINDOW AND STARTED ARGUING WITH HER AND THEN BEGAN PUNCHING AND BITING HER. SIMS ADVISED ADAMS FORCEFULLY GOT INTO HER PURSE AND STOLE HER CAR KEYS. SIMS ADVISED SHE BEGAN TO DEFEND HERSELF BUT THAT OTHER PEOPLE AT PICPAC PULLED HER OFF OF ADAMS. SIMS ADVISED SHE LEFT THE LOCATION AND WENT TO THE CIRCLE K ON FAIR PARK BLVD AND SAW ADAMS GETTING GAS THERE. SIMS ADVISED ADAMS LEFT WEST BOUND ON 630 AFTER HE FINISHED GETTING GAS. SIMS DOES HAVE A CURRENT PROTECTION ORDER AGAINST ADAMS (CR23392). OFFICERS OBSERVED A BITE ON SIMS' LEFT HAND AND A BUSTED BOTTOM LIP. SIMS DECLINED MEDICAL ATTENTION ON SCENE.
