## **NARRATIVE**

WHILE ON PATROL I WAS FLAGGED DOWN BY PHILLIPE HARRIS (V1) IN THE PARKING LOT OF THE FUN WASH LOCATED AT 3612 BASELINE RD.

MR. HARRIS STATED HE WAS ROBBED IN THE PARKING LOT OF THE APARTMENTS DOWN THE STREET (3801 BASELINE RD.). MR. HARRIS STATED AN UNKNOWN BLACK MALE WEARING A JASON HALLOWEEN MASK APPROACHED HIM AND SAID, "NIGGA GIVE ME YOUR SHIT." MR. HARRIS STATED THERE WERE TWO OTHER MALES WITH HIM BUT DID NOT REMEMBER ANYTHING ABOUT THEM. MR. HARRIS STATED THEY KNOCKED HIM TO THE GROUND, FOUGHT HIM. AND TOOK THE LISTED PROPERTY FROM HIM.

MR. HARRIS POINTED TO THE HALLOWEEN MASK THAT WAS IN THE PARKING LOT OF THE FUN WASH AND STATED THAT IT BELONGED TO THE SUSPECT. WHEN I ASKED HOW THE MASK GOT THERE, MR. HARRIS STATED HE CHASED HIM TO THE PARKING LOT. ACCORDING TO MR. HARRIS THIS HAPPENED AROUND 0400HRS.
