ON JULY 14TH, 2025, AT 2243 HOURS, OFFICERS RESPONDED TO MULTIPLE SHOT SPOTTER CALLS NEAR 4224 WEST 25TH STREET.

WHEN OFFICERS ARRIVED ON SCENE, THEY LOCATED SEVERAL SPENT CASINGS LYING ON THE GROUND. WHILE CANVASING NEARBY RESIDENCES, OFFICERS LOCATED SEVERAL SPENT CASINGS NEAR A TRUCK IN THE FRONT YARD OF 4224 WEST 25TH STREET. THE WHITE CHEVROLET TRUCK HAD BEEN STRUCK BY GUN FIRE ALONG WITH A RED CHEVROLET TRAVERSE IN THE DRIVEWAY. THE VICTIM, JULE TAYLOR, WAS NOTIFIED AND ALSO PROVIDED SECURITY FOOTAGE OF THE INCIDENT.

SECURITY FOOTAGE AT 4224 WEST 25TH STREET SHOWED TWO HOODED SUBJECTS FIRING PISTOLS EAST TOWARD THE DRIVEWAY OF 4218 WEST 25TH STREET BEFORE FLEEING NORTHBOUND ON ABIGALE STREET.

OFFICERS LOCATED TWO VEHICLES IN THE DRIVEWAY OF 4218 WEST 25TH STREET THAT HAD BEEN STRUCK BY GUNFIRE: A RED DODGE JOURNEY AND A WHITE CHEVROLET TAHOE. WHILE LOOKING OVER THE HOME, THE AWNING ABOVE THE FRONT DOOR HAD BEEN STRUCK BY GUNFIRE AS WELL. CONTACT WAS MADE WITH THE VICTIMS: NATASHA LEWIS, KYANNA THOMPSON AND RICARIO BRADLEY. ALL WERE INSIDE OF THE HOME WHEN THE GUNFIRE ERUPTED BUT NO ONE WAS INJURED.

ON 07/14/2025 OFFICERS RESPONDED TO THE LISTED LOCATION FOR ROBBERY OF BUSINESS.

UPON ARRIVAL OFFICERS WERE ADVISED THE SUSPECTS HAD LEFT THE SCENE PRIOR TO OFFICERS ARRIVAL IN THE LISTED VEHICLE.

UPON SECURING THE SCENE OFFICERS MADE CONTACT WITH AN EMPLOYEE/WITNESS, MR. KELLY. MR. KELLY ADVISED THAT TWO UNKNOWN BLACK MALES ENTERED THE STORE WITH FIREARMS. MR. KELLY ADVISED THE TWO SUSPECTS WERE IN ALL BLACK CLOTHING AND COVERING THEIR FACES. MR. KELLY STATED HE RAN OUT OF THE BACK DOOR SO HE COULD CALL THE POLICE.

OFFICERS THEN MADE CONTACT WITH THE OTHER EMPLOYEES, MS. PATTERSON AND J-1. MS. PATTERSON ADVISED THE TWO SUSPECTS POINTED THEIR FIREARMS AT HER AND J-1. MS.
