#### **NARRATIVE**

OFFICERS RESPONDED TO A SHOT SPOTTER ACTIVATION (SST) AT THE LISTED LOCATION. UPON ARRIVAL, OFFICERS OBSERVED MULTIPLE HOUSES HAD BEEN STRUCK BY GUN FIRE. OFFICERS ALSO LOCATED NUMEROUS SHELL CASINGS IN THE IMMEDIATE PROXIMITY. THE SHELL CASINGS LOCATED WERE OF DIFFERENT CALIBERS RANGING FROM 5.56 TO 9MM LUGER.

OFFICERS MADE CONTACT WITH THE LEWIS AND J1 WHO ADVISED THE WERE AT HOME WHEN THEIR RESIDENCE WAS STRUCK BY GUNFIRE. LEWIS ADVISED HIS TOYOTA TUNDRA HAD ALSO BEEN STRUCK BY GUNFIRE. OFFICERS DID OBSERVE BULLET HOLES AT THE RESIDENCE AND ON THE PICKUP. OFFICERS OBSERVED A RED HYUNDAI ELANTRA THAT HAD ALSO BEEN STRUCK BY GUNFIRE. OFFICERS WERE UNABLE TO MAKE CONTACT WITH THE OWNER OF THE VEHICLE DUE TO THE OWNER NOT BEING ON SCENE.

OFFICERS OBSERVED THE RESIDENCE AT 4501 WEST 28TH STREET TO BE STRUCK BY GUNFIRE. OFFICERS MADE CONTACT WITH JULIEN MORGAN AT THE RESIDENCE. MORGAN ADVISED HIS GIRLFRIEND AND DAUGHTER WERE ALSO IN THE RESIDENCE WITH HIM WHEN THE HOUSE WAS STRUCK BY GUNFIRE. MORGAN DID NOT WISH TO GIVE ANYMORE INFORMATION REGARDING THE INCIDENT. OFFICERS MADE CONTACT WITH TYRA JOHNSON AT 2719 WASHINGTON STREET REGARDING THE BULLET HOLES IN HER RESIDENCE. JOHNSON ADVISED SHE WAS AT HOME WHEN THE GUNFIRE STRUCK HER HOME.

OFFICERS WERE ABLE TO VIEW CAMERA FOOTAGE OF THE INCIDENT AT THE SCENE. A 12TH STREET SUPERVISOR RESPONDED TO THE SCENE AS WELL AS DETECTIVES. CSSU ALSO RESPONDED TO PROCESS ALL EVIDENCE REGARDING THE INCIDENT. OFFICERS SET UP A PERIMETER AROUND THE SCENE AS WELL AS STARTED A CRIME SCENE LOG DURING WHILE ON SCENE.
