NARRATIVE

ON 7/20/2025 AT APPROXIMATELY 2154 HOURS, OFFICERS WERE DISPATCHED TO 1321 MAIN STREET AT EZ MART IN REFERENCE TO A ROBBERY OF A BUSINESS CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE CASHIER, YEASIN ARAFAT.

YEASIN ARAFAT SAID HE WAS WORKING WHEN AN UNKNOWN BLACK MALE WEARING A BLACK HOODED JACKET WITH "JACKRABBIT SOCCER" ACROSS THE FRONT AND THE NUMBER 20 ON THE RIGHT SLEEVE, BLUE PANTS, GREY GLOVES, AND A MASK COVERING HIS MOUTH AND NOSE CAME INTO THE STORE. THE MALE ASKED ARAFAT TO BREAK A \$50 BILL AND WHEN ARAFAT LET IN THE MALE, THAT WAS WHEN THE MALE PULLED OUT A FIREARM FROM HIS WAISTBAND AND DEMANDED ALL OF THE MONEY FROM THE CASH REGISTER. ARAFAT SAID THE UNKNOWN SUSPECT DID NOT SAY ANYTHING ELSE. THE INCIDENT STARTED AT 2149 HOURS BASED ON THE CAMERA FOOTAGE.

AS THE AGGRAVATED ROBBERY TOOK PLACE, AN UNKNOWN BLACK MALE WEARING WHAT APPEARED TO BE A GREEN SHIRT, BLACK BACKPACK, DARK PANTS, AND WHITE SHOES ENTERED THE STORE AND ASKED ABOUT THE PRICE FOR A CUP OF ICE AND YEASIN ARAFAT TOLD HIM THE PRICE. THE UNKNOWN MALE LEFT AFTERWARDS. THE UNKNOWN MALE SUSPECT LEFT AT AROUND 2150 HOURS AFTER HE ROBBED THE STORE FOR APPROXIMATELY \$600 IN CASH. THE MALE SUSPECT RAN GOING IN A SOUTHEASTERN DIRECTION.

YEASIN ARAFAT ALSO SAID THE SAME MALE WHO ENTERED THE BUSINESS AS IT WAS BEING ROBBED WAS SEEN INTERACTING WITH THE ROBBERY SUSPECT. THE OTHER MALE WAS SEEN GOING SOUTH ON MAIN STREET AT THE TIME. ARAFAT BELIEVED THEY KNEW EACH OTHER.

OTHER OFFICERS ON-SCENE BROADCASTED UPDATED SUSPECT INFORMATION, DESCRIPTIONS, AND DIRECTIONS OF TRAVEL THROUGHOUT THE CALL. SGT J. FRAZIER AND SGT. J. SIMS WERE NOTIFIED OF THE INCIDENT. MAJOR CRIMES DIVISION WAS NOTIFIED AND DETECTIVE R. STUBENRAUCH ARRIVED TO TAKE OVER THE INVESTIGATION.

NARRATIVE

OFFICERS RESPONDED TO A CALL AT THE SPECIFIED ADDRESS. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE VICTIMS, WHO REPORTED THAT AN UNKNOWN INDIVIDUAL HAD FIRED A SHOT THROUGH THE FRONT WINDOW OF THEIR HOME. OFFICERS OBSERVED A BULLET HOLE IN THE FRONT WINDOW, AS WELL AS A SMALL HOLE IN THE LIVING ROOM WALL, INDICATING THAT THE BULLET EITHER PENETRATED THE WALL OR BECAME LODGED IN IT. OFFICERS ACCESSED THE WALL AND RETRIEVED A BULLET FRAGMENT. THEY QUESTIONED THE VICTIMS ABOUT ANY RECENT DISPUTES, AND THREE SEPARATE NAMES OF INDIVIDUALS WERE PROVIDED. MS. K. ELLIS STATED THAT SHE WAS IN THE LIVING ROOM WHEN SHE HEARD THE GUNSHOT BUT DIDN'T REALIZE IT HAD STRUCK HER HOUSE UNTIL SHE ENTERED THE ROOM AND NOTICED DEBRIS ON THE COUCH. ALTHOUGH SHE DID NOT SEE THE VEHICLE LEAVE, SHE HEARD ONE DRIVE AWAY ABRUPTLY. MS. ELLIS MENTIONED THAT SHE HAD PREVIOUSLY GIVEN A STATEMENT IN AN UNRELATED CASE, WHICH MIGHT OR MIGHT NOT BE CONNECTED. OFFICERS INFORMED THE ON-DUTY DETECTIVE OF THE TERRORISTIC ACT, WHO ARRIVED TO INTERVIEW THE VICTIMS AND PHOTOGRAPH THE BULLET HOLES. THE BULLET FRAGMENT WAS SECURED AT THE SOUTHWEST SUBSTATION. NO FURTHER POLICE ACTION WAS DEEMED NECESSARY. THE MOBILE VIDEO RECORDER (MVR) AND BODY-WORN CAMERA (BWC) WERE IN USE.
