OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A SHOOTING. UPON ARRIVAL OFFICERS MADE CONTACT WITH MR. PRICE WHO STATED HE SHOT HIS GIRLFRIEND IN THE HEAD. MR. PRICE WAS TAKEN INTO CUSTODY WITHOUT INCIDENT. OFFICERS LOCATED MS. GUAJARDO ON THE BACK PORCH SUFFERING FROM GUNSHOT WOUNDS AND APPARENTLY DECEASED. OFFICERS SECURED THE SCENE AND NOTIFIED HOMICIDE DETECTIVES AND CSSU, WHO RESPONDED TO THE SCENE TO BEGIN THEIR INVESTIGATION. THE PULASKI COUNTY CORONER WAS NOTIFIED AND RESPONDED TO THE SCENE TO TAKE CUSTODY OF MS. GUAJARDO'S BODY AND TRANSPORT IT TO THE ARKANSAS STATE CRIME LAB FOR AN AUTOPSY. NEXT OF KIN WAS NOTIFIED. AFTER FURTHER INVESTIGATION, MR. CORTEZ WAS CHARGED WITH CAPITAL MURDER AND TRANSPORTED TO PCRJ FOR HOLDING.
