### **NARRATIVE**

ON 07/28/2025, OFFICERS RESPONDED TO THIS LOCATION IN REFERENCE TO A BATTERY REPORT.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH JUVENILE 1. JUVENILE 1 STATED HE HAD JUST GOTTEN OUT OF PINNACLE POINT AND HAD RUN AWAY FROM HIS RESIDENCE. JUVENILE 1 STATED HE CALLED LRPD DUE TO BEING ROBBED APPROXIMATELY 40 MINUTES PRIOR TO SPEAKING WITH OFFICERS.

JUVENILE 1 STATED AN UNIDENTIFIED BLACK MALE APPROACHED HIM AND STARTED ASKING FOR JUVENILE 1'S PROPERTY HE HAD ON HIS PERSON. WHEN JUVENILE 1 REFUSED, THE INDIVIDUAL CLAIMED TO HAVE A FIREARM IN HIS POSSESSION AND AGAIN TOLD JUVENILE 1 TO HAND OVER HIS POSSESSIONS. JUVENILE 1 STATED THE INDIVIDUAL TOOK \$20 FROM JUVENILE 1 AND THEN LEFT THE AREA. JUVENILE 1 STATED HE LAST SAW THE INDIVIDUAL WALKING EAST FROM THE INTERSECTION OF WEST 24TH STEET AND SOUTH MONROE STREET.

JUVENILE 1 STATED THE INDIVIDUAL WAS A BLACK MALE, WEARING A BLACK SHIRT AND BLUE JEANS, JUVENILE 1 WAS UNABLE TO GIVE ANY FURTHER DESCRIPTION AT THIS TIME.

JUVENILE 1 STATED HE NEVER PHYSICALLY SAW A FIREARM DURING THIS INCIDENT BUT WAS SCARED DUE TO THE INDIVIDUAL CLAIMING TO HAVE ONE.

OFFICERS CIRCULATED THE AREA BUT WERE UNABLE TO LOCATE ANYONE MATCHING THE DESCRIPTION GIVEN BY JUVENILE 1.

WHILE EN ROUTE TO THE ACCIDENT, OFFICERS WERE ADVISED A PHYSICAL ALTERCATION HAD OCCURRED. OFFICERS OBSERVED ESTEVEZ TO HAVE MULTIPLE AREAS OF SWELLING ON HIS FACE AND FOREHEAD. ESTEVEZ ALSO HAD BLOOD COMING FROM A CUT ABOVE HIS RIGHT EYE. ESTEVEZ STATED HE BACKED INTO A VEHICLE DRIVEN BY KEMP IN THE PARKING LOT. ESTEVEZ STATED HE EXITED HIS VEHICLE AND BEGAN SPEAKING WITH KEMP. ESTEVEZ STATED ANOTHER SUBJECT ARRIVED ON SCENE, SUSP #2 (WOODRUFF), AND BEGAN DEMANDING FOR HIM TO PAY FOR THE DAMAGE OUT OF POCKET. ESTEVEZ STATED HE ADVISED WOODRUFF AND KEMP HE HAD INSURANCE, SO HE WOULD CONTACT THEM. ESTEVEZ STATED WOODRUFF BECAME MORE AND MORE AGITATED. ESTEVEZ STATED WOODRUFF APPROACHED HIM AND BEGAN STRIKING HIM WITH HIS FIST. ESTEVEZ STATED HE FELL TO THE GROUND AS WOODRUFF CONTINUED TO STRIKE HIM. ESTEVEZ STATED THE ASSAULT STOPPED AT WHICH POINT WOODRUFF AND KEMP FLED THE SCENE IN HER VEHICLE. WHILE SPEAKING WITH ESTEVEZ, HE BECAME AWARE HIS DEBIT CARD WAS MISSING FROM HIS WALLET, WHICH HE FOUND ON THE GROUND AFTER THE INCIDENT. IT WAS THEN LOCATED AT THE SCENE INSIDE THE FUNWASH. ESTEVEZ ADVISED OFFICERS THE CARD WAS USED AT THE LOCATION TO WITHDRAW \$450 FROM HIS ACCOUNT BEFORE THE CARD WAS CLOSED.

OFFICERS WERE ON SCENE WHEN KEMP RETURNED TO THE LOCATION. KEMP WAS DETAINED AND PLACED IN THE REAR OF A PATROL VEHICLE. KEMP STATED SHE WAS DRIVING HER VEHICLE WHEN ESTEVEZ BACKED INTO IT. KEMP STATED SHE CALLED WOODRUFF, HER BOYFRIEND, BECAUSE SHE FELT ESTEVEZ WAS BEING AGGRESSIVE. KEMP STATED WOODRUFF ARRIVED AND BEGAN SPEAKING TO ESTEVEZ. KEMP STATED A PHYSICAL ALTERCATION OCCURRED AND SHE OBSERVED SUSP #1 (REID), WHO WAS NOT INVOLVED IN ANY WAY UP TO THAT POINT, JOIN IN ON THE ASSAULT. KEMP STATED REID STRUCK ESTEVEZ DURING THE ASSAULT.

OFFICERS ATTEMPTED TO LOCATE WOODRUFF WITH NEGATIVE RESULTS.

OFFICERS MADE CONTACT WITH REID AT THE LOCATION AS WELL. REID DENIED ANY INVOLVEMENT IN THE INCIDENT. OFFICERS DETAINED REID AND PLACED HIM IN THE REAR OF A PATROL VEHICLE.

BOTH KEMP AND REID WERE TRANSPORTED TO THE 12TH STREET DETECTIVES' OFFICE TO BE INTERVIEWED. FOLLOWING THE INTERVIEWS, REID WAS TRANSPORTED TO PCRJ FOR THE LISTED CHARGES. KEMP WAS SUBSEQUENTLY RELEASED WITHOUT CHARGES.
