NARRATIVE

JACKSON ADVISED AS THEY APPROACHED HIS CAR, AN UNKNOWN SUSPECT IN A GRAY CHEVROLET CAMARO FIRED MULTIPLE SHOTS AT THEM, SHOOTING MR. MARBLEY ONCE IN THE LEFT CALF. MR. JACKSON STATED HE THEN TRANSPORTED MR. MARBLEY TO THE HOSPITAL. OFFICERS IN THE AREA OF WOODSON RD. AND YOUNG RD. WERE ADVISED BY OFFICERS WHO WERE WITH THE VICTIM AND WITNESS AT UAMS THAT THE SHOOTING OCCURRED AT 5600 YOUNG RD. THOSE OFFICERS CANVASSED THE AREA FOR SHELL CASINGS, LOCATING SIX 9MM SHELLS. A SUPERVISOR WAS NOTIFIED AND MAJOR CRIMES DETECTIVES ARRIVED ON SCENE SHORTLY AFTERWARD. OFFICERS RETRIEVED THE SHELL CASINGS AND STORED THEM AS EVIDENCE AT THE SOUTHWEST SUBSTATION.
