NARRATIVE

ORIGINAL INCIDENT OCCURRED AROUND 0127 HOUR REFERENCE INCIDENT NUMBER 2025-094755. THIS INCIDENT IS ALSO IN REFERENCE TO INCIDENT NUMBER 2025-094769.

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A CRIMINAL MISCHIEF. OFFICERS RECEIEVED A CALL FROM A 3RD PARTY ADVISED HER DAUGHERS RESIDENCE WAS SHOT AT AT THE ABOVE LOCATION. OFFICERS PREVIOUSLY RESPONDED TO A SHOTS FIRED CALL IN THE AREA OF 27TH AND STATE (2025-094755) AT 0127 HOURS BUT DID NOT HAVE A VICTIM OR CRIME SCENE AT THE TIME.

OFFICERS MADE CONTACT WITH PERRY AT THE RESIDENCE WHO ADVISED HE HEARD SEVERAL GUNSHOTS 20-30 PRIOR TO OFFICERS ARRIVAL. PERRY ADVISED WHEN HE HEARD THE SHOTS HE LAID ON THE GROUND UNTIL THEY STOPPED AND DID NOT SEE ANY VEHICLES OR SUBJECTS LEAVING THE AREA. OFFICERS OBSERVED AN ENTRANCE HOLE FROM THE PROJECTILE AND SHATTERED WINDOW. THE PROJECTILE CONTINUED THROUGH THE CAR DOOR AND INTO THE GLOVE BOX COMPARTMENT.

OFFICERS WERE ADVISED THAT HER BROTHER, MR. LEWIS, WAS DRIVING THE VEHICLE AT THE TIME IT WAS STRUCK BUT HAD NO INJURIES. MR. LEWIS WAS NOT ON SCENE AT THE TIME OFFICERS ARRIVED. OFFICERS OBSERVED THREE SPENT 9MM ROUNDS IN FRONT OF BUILDING E AND STORED THEM AS EVIDENCE.

OFFICERS MADE CONTACT WITH THE PROPERTY MANAGER, MRS. AUSTIN, WHO ADVISED SHE HEARD THE SHOTS BUT THOUGHT THEY WERE FIREWORKS. MRS. AUSTIN ALLOWED OFFICERS TO VIDEO FOOTAGE OF THE PROPERTY. OFFICERS OBSERVED THE FOOTAGE TO BE UNCLEAR AND DID NOT HAVE THE LOCATION FOR WHERE THE INCIDENT ACTUALLY OCCURRED.

OFFICERS CONTACTED MAJOR CRIMES DETECTIVES AND WERE ADVISED THAT DUE TO MR. LEWIS NOT BEING ON SCENE, THEY WERE NOT RESPONDING AND OFFICERS WERE TO STORE THE SPENT ROUNDS AND TO MAKE THE REPORT.

MR. BROWN DROVE THE VEHICLE BACK FROM THE LOCATION MR. LEWIS DROVE IT TO AND STAYED AT. MS. LEWIS IS LISTED AS A VICTIM DUE TO HER BEING INVOLVED IN THIS INCIDENT.

NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION IN REGARD TO AN UNKNOWN TROUBLE. OFFICERS WERE ADVISED THE CALLER GAVE THE LISTED ADDRESS AND ADVISED "PLEASE HURRY" AND DID NOT GIVE ANY FURTHER INFORMATION. WHILE EN ROUTE TO THE LOCATION OFFICERS WERE ADVISED A FEMALE HAD BEEN STABBED. UPON ARRIVAL OFFICERS OBSERVE A BLACK FEMALE ON THE GROUND IN THE LIVING ROOM WHO WAS LATER IDENTIFIED AS VIC#1 (MCCLURGE). OFFICERS OBSERVED A SEVERE LACERATION TO MCCLURGE'S CHIN ON THE RIGHT SIDE. OFFICERS DID NOT OBSERVE ANY OTHER INJURIES TO MCCLURGE'S BODY. WHEN CHECKING MCCLURGE FOR OTHER INJURIES DISCOVERED A GLASS PIPE WITH RESIDUE IN HER BRA. OFFICERS TOOK THE PIPE AND SECURED IT WHICH WAS LATER STORED FOR DESTRUCTION. OFFICERS OBSERVED A BLACK FOLDING KNIFE ON THE FLOOR NEXT TO MCCLURGE WHICH WAS TAKEN AND SECURED BY OFFICERS. OFFICERS MADE CONTACT WITH VIC#2 (DAVIS) WHO IS THE WIFE OF MCCLURGE. DAVIS STATED SUSP#1 (OUSLEY) AND MCCLURGE HAD GOTTEN INTO A VERBAL ALTERCATION AND SHE ATTEMPTED TO BREAK IT UP. DAVIS STATED OUSLEY BECAME UPSET DUE TO NOT BEING ABLE TO FIND HER MONEY. DAVIS STATED OUSLEY ADVISED SHE WAS ONLY ABLE TO LOCATE \$60 BUT STATED SHE HAD MORE THAN THAT. DAVIS STATED OUSLEY THEN WENT TO TAKE A SHOWER, GOT OUT OF THE SHOWER AND BEGAN LOOKING FOR HER MONEY AGAIN. DAVIS STATED OUSLEY MADE A PHONE CALL TO HER BROTHER, (SUSP#2 KOBE) AND ADVISED HIM TO COME TO THE LOCATION. DAVIS STATED SHORTLY AFTER, OUSLEY ALLOWED NUMEROUS OF SUBJECTS INTO THE APARTMENT, DAVIS STATED SHE OBSERVED 3 UNKNOWN B/M AND 2 B/F SUBJECTS ENTER THE APARTMENT. DAVIS STATED 1 B/M SUBJECT WHO SHE OBSERVED TO BE WEARING ORANGE PANTS, STATED, "Y'ALL HAVE 3 MINUTES TO MOVE AROUND OR I'M GONE AIR THIS BITCH OUT." DAVIS STATED SHE HEARD OUSLEY CALL HIM "KOBE," AS HE WAS HITTING AN ALCOHOL BOTTLE AGAINST THE WALL. DAVIS STATED AFTER KOBE WAS UNSUCCESSFUL AT BREAKING THE ALCOHOL BOTTLE, HE WENT INTO THE KITCHEN AREA AND GRABBED A KNIFE OUT OF THE COLORFUL DRAWER. OFFICERS WERE ADVISED THAT WHEN KOBE GRABBED THE KNIFE, HE ASKED WHO'S IT WAS AND SHE REPLIED IT WAS HER WIFE (MCCLURGE'S) KNIFE. DAVIS STATED KOBE HELD THE KNIFE TO HER THROAT AND STATED IF SHE SAID ONE MORE THING, HE WAS GOING TO "KNOCK HER BIG ASS OUT." SHORTLY AFTER KOBE MADE THE STATEMENT TO KNOCK HER OUT, SHE WAS JUMPED BY HIM AND A B/F BY THE NAME OF, "KAYLA." OFFICERS OBSERVED INJURY TO DAVIS' LIP AND SHE SUSTAINED A CHIPPED TOOTH. DAVIS REFUSED MEDICAL ATTENTION. OFFICERS MADE CONTACT WITH VIC#2 (GRIFFON) WHO ADVISED SHE IS THE GIRLFRIEND OF MCCLURGE. GRIFFON STATED SHE WAS IN HER BEDROOM AT THE TIME OF THE INCIDENT AND HER SON, VIC#4, WHO IS A JUVENILE, WAS IN THE LIVING ROOM ON THE COUCH. GRIFFON STATED SHE HEARD A COMMOTION COMING FROM THE LIVING ROOM. GRIFFON STATED SHE WENT IN THE LIVING ROOM AND OBSERVED ALL THE SUSPECTS IN THE LIVING ROOM. GRIFFON STATED SHE HEARD SUSP#2 (KOBE) STATE "YOU BETTER TAKE YOUR SON IN THE ROOM BEFORE I BEAT YOUR ASS TOO." GRIFFON STATED SHE GRABBED HER SON AND WENT IN HER ROOM. GRIFFON STATED WHEN THE SUSPECTS LEFT, SHE WENT INTO THE HALLWAY AND THEY RETURNED. WHEN SPEAKING TO GRIFFON, DAVIS STATED WHEN THE SUSPECTS RETURNED KOBE TOOK MCCLURGE PHONE AND WALLET. GRIFFON STATED KOBE KICKED THEIR DOG ACROSS THE LIVING ROOM AND OVER THE COUCH. OFFICERS DID NOT OBSERVE INJURY TO THE DOG. 3L36 (CHIDESTER) WAS ADVISED OF THE INCIDENT ALONG WITH MAJOR CRIMES. SGT THOMAS RESPONDED AND TOOK PICTURES OF THE SCENE. A BROADCAST WAS MADE IN REGARD TO THE INCIDENT. OFFICERS WERE ABLE TO REVIEW THE SURVEILLANCE FOOTAGE OF THE SUSPECTS IN THE HALLWAY.
