### NARRATIVE

IN REFERENCE TO INCIDENT NUMBER 2025-096851, OFFICERS RESPONDED TO THE LOCATION FOR A CALL OF SHOTS FIRED AT 2000 E. 6TH STREET. OFFICER FARMER OBSERVED 2 VEHICLES IN THE AREA WHERE THE SHOTS WERE HEARD. OFFICER FARMER CONDUCTED A TRAFFIC STOP ON THE SILVER SEDAN THAT WAS FOLLOWING A DARK GREY DODGE CHARGER. THE SILVER SEDAN STOPPED, AND THE DRIVER FLED. WHILE CIRCULATED FOR THE SUBJECT OFFICERS, THEY WERE THEN ADVISED THAT SOMEONE AT 503 FLETCHER STREET HAS CALLED AND STATED THAT THE HOUSE HAS BEEN SHOT UP. I RESPONDED TO THE LOCATION AND MADE CONTACT WITH DASHWAUNALL JOHNSON. JOHNSON ADVISED HE WAS IN THE BED SLEEPING AND HEARD THE SHOTS. HE THEN GOT UP AND OBSERVED THAT HE HAD BULLET HOLES IN HIS HOUSE. OFFICERS CHECKED OUTSIDE THE HOUSE AND LOCATED 1 40 CAL S&W CASING AND ONE BULLET HOLE IN THE FRONT OF JOHNSON'S TRUCK (AZL04H). OFFICERS THEN CHECKED INSIDE AND LOCATED 2 BULLET FRAGMENTS IN THE LIVING ROOM AND 1 IN THE DINING ROOM. OFFICERS NOTIFIED A DOWNTOWN SUPERVISOR AND MAJOR CRIMES DETECTIVE T. EVANS, WHO RESPONDED TO THE LOCATION.

WHILE RESPONDING TO 503, FLETCHER OFFICERS OBSERVED THADDEUS HIGGINS AND A FEW OTHER SUBJECTS CROWDED ON THE 600 BLOCK OF FLETCHER WATCHING THE CRIME SCENE IN A SUSPICIOUS MANNER. DUE TO KNOWING THADDEUS, OFFICERS KNEW THAT HIS UNCLE, BRANDON HIGGINS, IS THE ONLY PERSON IN THE AREA THAT DRIVES A DARK GREY CHARGER. OFFICERS MADE A BROADCAST AND ADVISED THAT BRANDON MIGHT BE THE DRIVER OF THE CHARGER (LPN: ASH87E). OFFICERS THEN WENT TO 1910 E. 4TH STREET, WHERE BRANDON LIVES, AND LOCATED MORE CASINGS (40 CAL S&W) IN FRONT OF THE LOCATION WHERE HE TYPICALLY PARKS HIS CAR. OFFICERS ALSO LOCATED 1 CASING ON THE PORCH OF 1910 E. 4TH STREET. OFFICERS KNOCKED ON THE DOOR AND MADE CONTACT WITH MARGARET HIGGINS, WHO WAS SLEEPING. SHE ADVISED SHE DID NOT HEAR ANY SHOOTING.

WHILE AT 503 FLETCHER STREET, OFFICERS OBSERVED A BLACK CHALLENGER THAT CONTINUOUSLY CIRCULATED THE AREA AND THEN STOPPED AT 6TH AND FLETCHER WITH A GROUP OF INDIVIDUALS. OFFICERS THEN INFORMED OTHER OFFICERS CIRCULATING IN THE AREA. THE BLACK CHALLENGER (BGG86L) WAS STOPPED AT 4TH AND KIMBALL STREET. OFFICERS MADE CONTACT WITH THE DRIVER, ANGELICA BOSTON, AND THE PASSENGER, BRANDON HIGGINS. OFFICERS HAD BOTH SUBJECTS EXIT THE VEHICLE, AND BRANDON WAS DETAINED. ANGELICA STATED SHE WAS CALLED BY BRANDON AND HE ASKED HER TO PICK HIM UP AT THE INTERSECTION OF 33RD AND ELAM STREET. SHE THEN DROVE HIM TO WHERE HE TOLD HER TO GO. BRANDON WAS SEARCHED AND DID NOT HAVE ANY WEAPONS ON HIS PERSON. OFFICERS THEN CONDUCTED A WARRANT SEARCH, WHICH SHOWED THAT HE HAD 2 WARRANTS. A FTA FROM PULASKI COUNTY (PC-23-6535) AND A FTP FROM LITTLE ROCK (LR-24-10165). BRANDON WAS TRANSPORTED TO PCRJ FOR THOSE WARRANTS AND WAS ISSUED A TRAFFIC CITATION (200A3554501). BOSTON AND THE VEHICLE WAS THEN RELEASED.

OFFICERS THEN WENT TO 33RD AND ELAM STREET AND LOCATED THE DARK GREY CHARGER THAT APPEARED TO HAVE 1 BULLET HOLE ON THE PASSENGER SIDE OF THE FRONT BUMPER. THE VEHICLE WAS THEN TOWED AND SENT TO THE CRIME SCENE BAY. OFFICERS THEN COLLECTED THE CASINGS AND BULLET FROM 1910 E. 4TH STREET. OFFICERS THEN STORED THE BULLET, FRAGMENTS, AND CASINGS IN THE 12TH STREET PROPERTY ROOM. NO FURTHER POLICE ACTIONS WERE TAKEN, AND BWC/MVR WAS IN USE.
