NARRATIVE

ON AUGUST 12, 2025, OFFICERS RESPONDED TO 2213 VALMAR STREET FOR A DOMESTIC DISTURBANCE. UPON ARRIVAL, OFFICERS MADE CONTACT WITH DYER AND KENDRICK ON THE FRONT PORCH. KENDRICK IS DYER'S MOTHER. DYER ADVISED SHE WAS IN A DISTURBANCE WITH HER EX-BOYFRIEND, CALDWELL, WHICH TURNED PHYSICAL.

DYER STATED CALDWELL BECAME UPSET WITH HER FOR LIVING AT HER MOTHER'S HOUSE. DYER STATED SHE AND CALDWELL WERE ARGUING IN HIS VEHICLE WHICH WAS PARKED IN FRONT OF THIS LOCATION. DYER STATED SHE GOT OUT OF THE VEHICLE AND TRIED TO WALK INSIDE THE HOUSE. CALDWELL PURSUED HER, GRABBED HER BY THE NECK, AND TOOK HER PURSE WHICH CONTAINED HER DEBIT CARD AND CELL PHONE AND LEFT THE SCENE.

KENDRICK ADVISED OFFICERS THE STRUGGLE WAS CAUGHT ON THE HOME'S RING DOORBELL CAMERA. OFFICERS VIEWED THE CAMERA FOOTAGE AND WERE ABLE TO SEE PART OF THE STRUGGLE BUT THEY WENT OUT OF VIEW JUST PRIOR TO CALDWELL GRABBING DYER BY THE THROAT.

DYER STATED WHEN CALDWELL GRABBED HER BY THE THROAT SHE WAS ABLE TO BREATHE BUT IT WAS RESTRICTED. OFFICERS OBSERVED A CUT TO THE LOWER LEFT SIDE OF DYER'S THROAT, CONSISTENT WITH A HUMAN FINGER NAIL DIGGING INTO IT.
